Notes:

- (v) Revocation of an officially named Crown Protected Area will require the name to be discontinued and removed.
- (vi) Reclassification of an officially named Crown Protected Area will require a formal proposal to alter it.
- (vii) The information you supply is subject to public scrutiny. Information provided in this form and any attachments, will be held by Land Information New Zealand *Toitū te whenua*, and may be used for the purpose of public consultation on your Crown Protected Area Name proposal. In particular, information may be provided to, and used by, Te Puni Kōkiri (the Ministry of Māori Development) or other government agencies, for enabling consultation on your Crown Protected Area Name proposal with appropriate Māori groups. The provision of information on this form and any attachments is not mandatory or required by law, but failure to provide the information will mean that your Crown Protected Area Name proposal cannot be considered.
- (viii) Information considered to be culturally, historically or spiritually sensitive will be treated with respect.
