IN THE MATTER of an instrument of Alienation being an Agreement for Sale and Purchase


AT a sitting of the Court held at Whanganui on the 23rd day of April 2013 before Layne Ross Harvey, Judge

WHEREAS an application for confirmation of an Agreement for Sale and Purchase was filed by John Tizard for Kura Marie Teira and other trustees of the Ngahina Trust being the proprietors, to transfer all of the land known as Ngarara West E (being Lots 2, 4 and 5 DP 72985) being 10.0084 hectares to the Kapiti Coast District Council for the consideration of \$6,270,000.00 plus GST

AND WHEREAS the Court is satisfied that the Agreement for Sale and Purchase dated 15 July 2008 is an instrument of alienation to which section 151 and 152 of Te Ture Whenua Māori Act 1993 applies and the alienation purporting to be effected by that instrument has been effected in all respects in accordance with the law in force at the time of the execution of that instrument
