

Response to your official information request

Thank you for your official information request received on 22 November 2023 for information regarding Toitū Te Whenua Land Information New Zealand (LINZ)'s use of vehicles, taxis and ride-sharing apps.

Some of the information you have requested is enclosed.

However, information relating to the number of kilometres travelled by staff via land transport in the 2022/23 financial year has been refused under Section 18(f) of the Official Information Act because the information requested cannot be made available without substantial collation or research.

- What was the department's taxi expenditure for the 2022/23 financial year?
 The total expenditure for taxis was \$81,238.99
- 2. What was the department's expenditure on ridesharing apps (such as Uber, Ola, Zoomy, YourRide etc) for the 2022/23 financial year?

The total expenditure for ridesharing apps was \$4,150.24

a. If the agency does not separate out taxi expenditure from other ride sharing expenditure, please indicate whether ridesharing or taxi use is the default/most common when such a service is needed and provide and a rough estimate of the proportion of trips that are taken via ridesharing vs taxi.

3. What was the department's expenditure on public transport (busses, trains, ferries, etc) for the 2022/23 financial year?

The total expenditure on public transport was \$529.00

The total spend for rental cars for the period was \$34,501.35
