

Title LandXML Import Parcel Check for Easements to be Surrendered/Covenants to be Revoked **Enhancement** LOLCM-3518 (External) **Description** Two new Parcel Intents 'Easements to be Surrendered' and 'Covenants to be Revoked' have been identified as having issues once a LandXML file, containing parcels with these intents, is imported into the appropriate Survey Purpose. 1) Users were not being alerted to a Y626 rule in pre-validation immediately after import. 2) Elements of the appellation are not being mapped into Landonline tables. Description	New notice template Triggers a 'your dataset has been selected for processing' notice to the surveyors. This occurs the first time a Validator (LINZ) clicks on the perform button of the CSD in Desktop workflow.

Title	LandXML Mappings (for Importing) are Not Working for Standard Unit Plans, PUD's, or SPUD's		
Enhancement	LOLCM-3574 (External)		
Description	The LandXML mappings are not working for Standard Unit Plans, PUD's, or SPUD's, forcing users to manually go and edit all the parcel details that have not been successfully imported.		
Action	Fixed		
	Criteria required in the LandXML file to be imported along with the normal header information in a LandXML file is as follows:

	One Monument name		
	Once CgPoint

- Parcel name:
 - Principal Unit 1
 - Principal Unit 1A
 - Accessory Unit 1
 - Principal Unit 1A

Note: Parcel name must be a valid format, can include a numeric, numeric and alpha. If they are not valid formats, then post import Y626 will appear indicating the invalid parcel format that require amending (see first bullet point under notes at the end of this enhancement).

- Parcel state:
 - Referenced (the fee simple parcel the Units are over)
 - Proposed (for PUDs and SPUDs)
 - Created (for Standard Unit Plans)
- Parcel class:
 - building (for Principal Units)
 - accessory building (for Accessory Units)



Once the LandXML file is imported into Landonline:

 Prevalidation report will return rules Y012 and Y016 – the mark imported needs to be deleted (if no spatial data is being captured)

NOTE:

- If parcels are imported with the incorrect appellation format, then pre-validation will report rule Y626 and list the parcels that need to be amended.
- If no 'Referenced' parcel is imported, ensure the fee simple parcel the unit development is over is added as 'Referenced' in the parcel list.
- No mappings exist for 'Subsidairy Proposed Unit Plans'.
- Stages to unit development plans (i.e. 1st stage, stage, complete etc) are not recommended to be imported as the parcels on those stages require searching for the Proposed Parcels and editing the Parcel Intents.

Title	Automated Survey Report Bearing Adjustments Section Mixing Up Comments Against Plans		
Defect	LOLCM-3602 (Internal and External)		
Description	Referenced Plans are entered in the Header panel (upon import or manual entry) and can indicate bearing corrections or not. Where bearing corrections have been identified, these plans also get listed in the Automated Survey Report under the Section 2(b) Bearing Adjustments and 'comments' can be added against each plan to report on the bearing correction. If any new Referenced Plans are added in the Header panel after updating the Automated		
	Survey Report, then the comments added under Section 2(b) of the Report were b mixed up against other plans:

Title	Update the Topology field to Allow Selection of 'Primary' for Parcel Intent 'Marginal Strip – Fixed'	
Enhancement	LOLCM-3611 (External and Internal)	
Description	The ability to create a Marginal Strip – Fixed parcel with Primary topology had inadvertently been removed. This needs to be reinstated.	
Action	Fixed	
	Parcels that have the Parcel Intent – 'Marginal Strip – Fixed' can now be captured with primary topology.	
	NOTE: There is no LandXML mapping to separate 'Marginal Strip' or 'Marginal Strip – Fixed' and so if you have the latter present in the LandXML file, be aware these will not import as primary parcels.
