A. Application of the Act

- 3. Section 29A(1) of the Act provides that a person may apply at any time for an assessment under the investor test that is not part of an application for consent under the Act.⁴
- 4. The application may include persons who together are contemplating an overseas investment transaction, and persons who would be associates of those persons should the transactions go ahead.⁵
- 5. The investor test is met in respect of an investor if you are satisfied that:
 - None of the investor test factors are established;⁶ or
 - Any investor test factor or factors that are established do not make the investor unsuitable to own or control any sensitive New Zealand assets.
- 6. To make a determination under s 29A, you must also be satisfied that none of the relevant overseas person(s) or individuals with control have been an investor in respect of a transaction of national interest for which consent was declined for reasons connected to that investor under section 20C.⁷

B. Assessment

7. This section describes the Applicant, assesses whether the investor test is met, and assesses whether a determination can be made under s 29A.

Business Activities

- 8. The Applicant is engaged in the development, operation, and maintenance of airports. Its business activities include airport design, construction, managing day-to-day activities, and maintaining service standards for safety and efficiency.
- 9. The Applicant has 7 airports in operation and 2 under development. Its key operations are in Delhi, Hyderabad, Goa and Medan.

Ownership and control

- GMR Airports imited is primarily based in India and is ultimately owned by GMR Group, Groupe ADP and is publicly listed.
- 11. GMR Airports International B.V. is an intermediary company and its registered business office is in Amsterdam. It is wholly owned by GMR Airports Limited, and holds GMR Airports Limited's investments in various countries.

Summary of investor test

15. The relevant overseas persons and individuals with control established none of the factors contained in section 18A(4) of the Act, therefore we consider the **investor test has been met**.

Transactions of national interest

- 16. None of the relevant overseas person(s) or individuals with control have been an investor in respect of a transaction of national interest for which consent was declined for reasons connected to that investor under section 20C.
- 17. For this reason, LINZ are not aware of any circumstances which prevent a determination being made under s 29A(5).

C. Conclusion

- 18. For the reasons set out in this report, we consider that **the investor test has been met** in relation to the listed entities and overseas individuals, and there are no circumstances which prevent a determination being made.


