RE: Resource Consent Applications – Former Tokanui Hospital Remediation and Landfill Upgrade

Toitū Te Whenua Land Information New Zealand (LINZ) is lodging resource consent applications for the demolition and remediation of buildings at the former Tokanui Hospital site, 149 Te Mawhai Road, Tokanui.

- The first application is for the substantial remediation works across the main hospital site (west of the Wharekorino Stream), referred to as the Remediation Application.
