



# Release notes for conveyancers (3.12 Property Tax Release)

Landonline release 3.12 introduced small changes to allow the entry of property tax information in some transactions.

From 1 October 2015, purchasers and vendors are required by legislation to prepare and sign a statement containing the required tax information before a property can be transferred.

Tax information provided to LINZ is treated as personal information does not form part of the public Land Transfer Register.

Conveyancers are required to provide the declared information before certifying the property transfer, but do not need to certify the accuracy of the information provided. The information collected by LINZ is forwarded to Inland Revenue for tax compliance purposes, and will only be publicly disclosed in forms that protect the privacy of individuals.

Changes were made in the Landonline 3.12 release to allow capture of tax information and addition of business rules to check that tax information has been supplied before the transaction can be signed and completed.
