#### 4. Analysis of Submissions

# 4.1. Introduction

Each of the submissions received has been reviewed in order to identify the points raised and these have been numbered accordingly. Where submitters have made similar points these have been given the same number.

The following analysis:

- 1. Summarises each of the points raised along with the recorded number (shown in the appended tables) of the submitter(s) making the point.
- 2. Discusses each point.
- 3. Recommends whether or not to allow the point for further consideration.
- 4. If the point is **allowed**, recommends whether to **accept** or **Not accept** the point for further consideration.

The points raised have been analysed to assess whether they are matters that are validly-made, relevant to the tenure review and can be properly considered under the Crown Pastoral Land Act 1998 (CPLA). Where it is considered that they are the decision is to allow them. Further analysis is then undertaken as to whether to accept or not accept them.

Conversely where the matter raised is not a matter that is validly-made or relevant or can be properly considered under the CPLA, the decision is to **Disallow**. The process stops at this point for those points disallowed.

The outcome of an accept decision will be that the point is considered further in formulation of the draft SP. To arrive at this decision the point must be evaluated with respect to the following:

The objects and matters to be taken into account in the CPLA; and

Whether the point introduces new information or a perspective not previously considered;  $\underline{or}$ 

Where the point highlights issues previously considered but articulates reasons why the submitter prefers an alternative outcome under the CPLA; or

Is a statement of support for aspects of the Preliminary Proposal which can be considered by the Commissioner when formulating the designations for a Substantive Proposal.

How those accepted points have been considered will be the subject of a Report on Public Submissions which will be made available to the public. This will be done once the Commissioner of Crown Lands has considered all matters raised in the public submissions in formulating a Substantive Proposal.

Allowing recreational hunters into the proposed conservation area is a post tenure review management matter designed to control animal pests. It is not a matter that the Commissioner can consider in the formulation of a Substantive Proposal and it is therefore disallowed.

The proposal meets the objects of Part 2 of the CPLA and the point raised by the submitter is a statement of support for the proposal. This point is therefore allowed.

# Rationale for Accept:

As the point relates to the objects and matters to be taken into account in the CPLA, and the submitter makes a statement of support for aspects of the Preliminary Proposal, it is accepted for further consideration by the Commissioner in the formulation of a substantive proposal.

#### Rationale for Allow:

The object of Section 24(b) of the CPLA is to protect the SIVs identified on the reviewable land and the point raised by the submitter relates to the protection of the values. This point is therefore allowed.

Rationale for Accept:

The point meets the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. The point introduces a perspective not previously considered. The inclusion of the Red Hut was not something that was sought by DoC and therefore not specifically discussed during consultation.

Rationale for Allow:

Section 24(b) of the CPLA is to enable the protection of the SIVs of the reviewable land. Heritage values if present on the reviewable land could be considered an SIV. As this point relates to the protection of the SIVs it is therefore allowed.

Rationale for Accept:

The point does meet the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. This is because it relates to the objects and matters to be taken into account in the CPLA, the point introduces new information or a perspective not previously considered.

The historic information provided by DoC in the CRR was based on field inspections and previous reports carried out on the property. The submitter suggests there may be two additional sites requiring assessment.

As the point relates to the objects and matters to be taken into account in the CPLA, and the submitter makes a statement of support for aspects of the Preliminary Proposal, it is accepted for further consideration by the Commissioner in the formulation of a substantive proposal.

#### Rationale for Disallow:

The management of conservation areas post tenure review is not a matter for the Commissioner. The point is therefore disallowed.

#### Rationale for Allow:

Section 24(c)(ii) provides for the freehold disposal of the reviewable land and Section 24(b)(i) the protection of the SIV's by the creation of a protective mechanism. As this point relates to these aspects, it is therefore allowed.

#### Rationale for Accept in part:

As the point relates to the objects and matters to be taken into account in the CPLA, and the submitter makes a statement of support for aspects of the Preliminary Proposal, it is accepted for further consideration by the Commissioner in the formulation of a substantive proposal. The submitter also refers to the control of wilding pines, gorse and broom. The covenant does provide for the control of weeds, which would include gorse and broom. There is also a clause requiring the owner to keep the land free of exotic trees. This part of the point therefore does not introduce any new information or a perspective not previously considered.

#### Rationale for Allow:

The object of Section 24(b) of the CPLA is to protect the SIVs identified on the reviewable land and the point raised by the submitter relates to the protection of the values by ensuring the values are not damaged by stock grazing. This point is therefore allowed.

#### Rationale for Not Accept:

The point does not meet the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. While this point meets the objects and matters to be taken into account in the CPLA, it does not introduce any new information or a perspective not previously considered.

By way of explanation there is some confusion about the details surrounding stock grazing the covenant area. The summary inadvertently referred to the covenant allowing grazing. CC1 was originally the designation proposed on the area now designated CA1 and it was proposed that the grassy areas between the bush and the fence could be grazed. The covenant document clearly states that grazing is not permitted on CC1. The covenant is not fully fenced due to the contour. This will result in some unintentional grazing of the covenant and the wording of the covenant may need to be looked at to cater for this. The covenant allows for monitoring and any damage caused from unintentional grazing will be picked up as part of this process.

The object of Section 24(b) of the CPLA is to protect the SIVs identified on the reviewable land and the point raised by the submitter relates to the protection of the SIV's by ensuring they are not damaged by growing exotic pine trees. This point is therefore allowed.

#### Rationale for Not Accept:

The point does not meet the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. While this point meets the objects and matters to be taken into account in the CPLA, it does not introduce any new information or a perspective not previously considered.

Clause 3.2.3 of the covenant documents requires the owner to keep the land free of exotic trees.

While fencing is often undertaken as part of implementing a tenure review designation, this is not specifically a tenure review matter. In this case the fencing is not part of the tenure review, but being undertaken by the holder before implementation. The point is therefore disallowed.

Rationale for Allow:

The object of Section 24(b) of the CPLA is to protect the SIVs identified on the reviewable land and the point raised by the submitter relates to the protection of the values by seeking to enlarge the area included in the covenant. This point is therefore allowed.

Rationale for Accept:

The point does meet the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. The submitters have introduced potentially new information or a perspective that may not previously have been considered. This location of the covenant was well canvassed during consultation, however the submitters refer to a supply catchment area and this may constitute new information.

Rationale for Allow:

The object of Section 24(b) of the CPLA is to protect the SIVs identified on the reviewable land and the point raised by the submitter relates to the protection of the values by suggesting a covenant would not adequately protect the values, and the land should be designated as a conservation area. This point is therefore allowed.

Rationale for Accept:

The point meets the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. The point introduces new information or a perspective not previously considered and articulates reasons why the submitters prefer an alternative outcome under the CPLA. The recommendation from DoC was that a covenant would adequately protect the values and as a result the option of designating this area as a CA was not canvassed during consultation with the holder.

The object of Section 24(c)(i) of the CPLA is to make easier the securing of public access to and enjoyment of the reviewable land and the point raised by the submitter relates to this point. This point is therefore allowed

Rationale for Accept:

The point meets the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. The submitters have introduced new information or a perspective that may not previously have been considered. Access to CC1 and CC2 was not sought by DoC and therefore did not form part of the consultation process.

Rationale for Allow:

The object of Section 24(b) of the CPLA is to protect the SIVs identified on the reviewable land and the point raised by the submitter relates to the protection of the values by suggesting the SIV's require the area to be designated as a conservation area. This point is therefore allowed.

Rationale for Not Accept:

The point does not meet the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. While this point meets the objects and matters to be taken into account in the CPLA, it does not introduce any new information or a perspective not previously considered. While the submitters have suggested an alternative in relation to the designation, this is not new information as it was considered during the consultation process. The proposed covenant area was originally recommended by DoC as part of a larger conservation area incorporating more of the Waianakarua faces.

During the initial consultation with DoC and the holder, a revised area and designation for the Waianakarua faces was discussed. This resulted in a reduced conservation area (CA1) centred on the steep bushy faces. This did not include the area now included in CC3. While there is no specific note outlining consultation on whether this area should be designated a conservation area, correspondence from DoC supported a covenant as an appropriate mechanism.

The submitters have introduced new information or a perspective that may not previously have been considered. Access to CC3 was not sought by DoC and therefore did not form part of the consultation process.

#### Rationale for Allow:

The object of Section 24(b) of the CPLA is to protect the SIVs identified on the reviewable land and the point raised by the submitter relates to the protection of the values by suggesting the boundary fencing of the proposed conservation area may not be adequate to protect the values. This point is therefore allowed.

#### Rationale for Accept:

The point meets the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. The submitters have introduced new information or a perspective that may not previously have been considered. The portion of CA1 mentioned by the submitter was thought to be fenced already. If this is not the case then additional fencing needs to be considered.

#### Rationale for Allow:

The object of Section 24(b) of the CPLA is to protect the SIVs identified on the reviewable land and the point raised by the submitter relates to the protection of the values by suggesting a covenant is required to protect the wetland areas from cattle damage. Section 40(2)(a) allows for the use of a "Protective Mechanism" to protect the SIV's. This point is therefore allowed.

## Rationale for Accept:

The point meets the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. The submitters have introduced new information or a perspective that may not previously have been considered. The use of a covenant to restrict cattle grazing was not specifically discussed on this area and therefore did not form part of the consultation process.

The point meets the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. The point introduces new information or a perspective not previously considered. Access to CC3 was not sought by DoC and has not been considered during the preparation of the preliminary proposal.

Assuming the land is designated as a conservation area, the use of the Red Hut post tenure review would be a management decision by DoC. This is therefore not a matter for the Commissioner to consider and as a consequence the point is disallowed.

# Rationale for Allow:

The object of Section 24(c)(i) of the CPLA is to make easier the securing of public access to and enjoyment of the reviewable land and the point raised by the submitter relates to this point. This point is therefore allowed.

#### Rationale for Not Accept:

The point does not meet the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. While this point meets the objects and matters to be taken into account in the CPLA, it does not introduce any new information or a perspective not previously considered. By way of explanation there was a comment in the summary that could have been interpreted as suggesting vehicle access was provided to Bells Saddle. This caused some confusion from the submitters whether the vehicle access was over the full length of the easement or just over a-b-c. The legal documents attached to the proposal document supplied to the submitters were quite clear about this point. Further clarification is therefore not required. Vehicle access was the major issue in this review and it was discussed at every consultation meeting with the holder and DoC.

The object of Section 24(b) of the CPLA is to protect the SiVs identified on the reviewable land and the point raised by the submitter relates to the protection of the values by suggesting the land in question has SIV's that require protection and should be designated as a conservation area. This point is therefore allowed.

# Rationale for Not Accept:

The point does not meet the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. While this point meets the objects and matters to be taken into account in the CPLA, it does not introduce any new information or a perspective not previously considered. This area was originally recommended for Crown ownership by DoC. During consultation, DoC reviewed the values present and as a result did not consider the values needed any formal protection.

not sought by DoC and has not been considered during the preparation of the preliminary proposal.

The option of using a SMC was considered in the recommendations to LINZ and although not specifically recorded, was considered during consultation but not thought to be the appropriate mechanism for this area.

Rationale for Allow:

The object of Section 24(b) of the CPLA is to protect the SIVs identified on the reviewable land and the point raised by the submitter relates to the protection of the values by suggesting the land in question has SIV's that require protection greater than that provided with the present designation. This point is therefore allowed.

Rationale for Accept:

The point meets the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. The point highlights issues previously considered but articulates reasons why the submitter prefers an alternative outcome under the CPLA <u>and</u> the point introduces new information or a perspective not previously considered. The submitters are concerned that conservation land created from tenure review is considered Stewardship Land by DoC and as a consequence the SIV's will not be adequately protected. This aspect has not been considered as part of the preliminary proposal.

While this point suggests support for an aspect of the proposal, the main aspect of this point is the protection of the tussock grassland. This point will be discussed in conjunction with point 22 above.

Rationale for Not Accept:

The point does not meet the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. While this point meets the objects and matters to be taken into account in the CPLA, it does not introduce any new information or a perspective not previously considered. While the submitter articulates reasons why an alternative outcome is preferred under the CPLA, the option of the boundary of CC1 was well canvassed during the consultation phase. Consideration was given to extending the area further west, however the proposed boundary was thought to be a practical boundary line for the covenant.

Rationale for Allow:

The object of Section 24(c)(i) of the CPLA is to make easier the securing of public access and enjoyment on the reviewable land and the point raised by the submitter relates to this point. This point is therefore allowed.

Rationale for Accept:

The point does not meet the criteria for acceptance by the Commissioner for further consideration in the formulation of a Substantive Proposal. While this point meets the objects and matters to be taken into account in the CPLA, it does not introduce any new information or a perspective not previously considered. Public access provisions are an important aspect of this proposal. Access is provided to CA1, passed the conservation covenants and to the rear of the property to meet up with easements on Kinross. It also provides access to the existing Reserve on the southern boundary. The provisions certainly make easier the securing of public access and also the enjoyment of the reviewable land in CA1 and the balance of the property along the easement length. Point 28 will consider further aspects of public access.

#### **Summary and Conclusion**

### Overview of analysis

In analysing the 11 submissions received 43 points were identified. Of the 43 points raised, 31 were allowed for further consideration. Of the 31 that were allowed, 21 have also been accepted in total or part for consideration in the preparation of a draft substantive proposal. This was largely on the basis on the provision of new information or the submitter provided reasons why an alternative outcome should be considered, or was a statement of support for aspects of the proposal. Of the 21 accepted for further consideration 7 were statements of support for aspects of the proposal.

In total there were 43 points raised, of which 21 are "Allowed" and "Accepted" for further consideration, 10 "Not accepted" and 12 points "Disallowed" and will not be considered further.

# Generic Issues

There was strong support for the retention of CA1 in Crown ownership. A number of submitters also considered the three conservation covenants should also be retained in Crown ownership. Public access was another point of some concern. There was some confusion about the public vehicle access provisions, with a number of submitters thinking vehicle access was provided to Bells Saddle.

A further point raised was the decision to designate the CA1 as a conservation area rather than as a reserve. The recent release of the Commissioner of the Environment report on Stewardship Land has resulted in a change in thinking by NGO's in relation to how the land is designated.

Gaps identified in the proposal or tenure review process

None identified.

Risks identified

No specific risks have been identified through the public notification process.

# General trends in the submitters' comments

The common issues raised were:

- The need to include CC1, CC2 and CC3 in the proposed conservation area.
- · The need for additional public access over Mt Miserable.
- Support for CA1.
- A push to have the conservation area changed to a Reserve.
