This is a brief message to convey my wishes to have public access to the Pink Elephant boulders for rock climbers, walkers, geologists and anyone with an interest in conservation. I understand the land is up for tenure review, and my friends and I who climb here often would like to recommend protecting the land around the boulders to keep it in Crown ownership.

This is one of the only areas of easy access that contains a large number of boulders. These boulders were left after the retreat of Tasman Glacier over 10,000 years ago, and to wander in the boulder clad valley is an experience many people would enjoy. A number of the larger boulders have been equipped with top rope anchor points for safety and to allow beginners to enjoy the climbing here too.

As New Zealand citizens who visit the McKenzie Country frequently we strenuously object to thos proposal. The landscape of this area is a significant inherent value which must be preserved and this proposal does not have this intention, we submit that it should be returned to the full Crown ownership and control.

We oppose the preliminary proposal in its entirety as it fails to protect extensive areas which have significant inherent values and seek that it be either renegotiated to ensure protection of the SIVs or withdrawn to enable it to be informed by the outcomes of the collaborative planning process.

We do not see that the proposal " makes easier the securing of public access to and enjoyment of reviewable land" (CPLA 1998 Section 24 (b)).

Neither does the proposal "Promote the management of reviewable land in a way that is ecologically sustainable" as it should under Section 24 (a) (i) of the Crown Pastoral Lands Act 1998.

Maryburn

As Maryburn pastoral lease is in the centre of the Mackenzie Basin, and extends west from the Tekapo River across the glacial outwash plains of the Maryburn Flats to Maryburn Stream, it and it's second block including the southwestern end of the Mary Range to Lake Pukaki are pivotal to the lanscape of the Mckenzie Baisin.

Maryburn outwash plain - we request protection as public conservation land We believe that this entire triangle of land between SH8 and Tekapo River should be protected as conservation land to protect the full range of SIVs - the unique vegetation communities and species on the full suite of fluvio-glacial outwash and younger alluvial terrace and floodplain features. This is one of the classic Mackenzie views of short tussock-covered outwash plains. . The land identified as a Sustainable Management Covenant (SMC) should be included as public conservation land as it contains dryland species and systems that complement the adjoining area.

Lake Pukaki and crest of Mary Range - including Pukaki lateral moraine - we request protection as public conservation land This 1,293ha area of moraine should be protected as conservation land for its SIVs, including the nationally significant terminal moraine site, the acutely and chronically threatened plants, the outstanding predominantly natural sequence of significant ecosystems, including short tussock grasslands and remnant shrublands on low hill country, alluvial terraces, stony fans and terraces, kettleholes and turf communities.

Eastern slopes of Mary Range - we request a landscape covenant This area requires a sustainable land management or a landscape covenant to protect the outstanding landscape SIVs as it is relatively unmodified with few structures and a significant feature when viewed from SH8.

Mary Burn Stream and wetlands - we requst protection as public conservation land This area should be protected as a conservation area as it is habitat for threatened longfin eel, koaro, black-fronted tern, black stilt and banded dotterels. Freeholding would not promote the ecologically sustainable management of the stream and wetlands.

Northern wetland - we request protection under S77 Reserves Act This site of special wildlife interest for birds should be protected by a covenant to ensure ecologically sustainable management. Ongoing grazing will result in continued degradation.

My name is Kevin Donoghue, I live at 176 Mount Pleasant Road in Christchurch.

I wish to raise the following issues as a submission in regards to the preliminary proposal for Maryburn Station in the Mackenzie Basin.

In particular I wish to raise the issue of public access to the spectacular boulders within the Pink Elephant Boulder Area that constitutes part of the reviewable land. I submit that subject to s24(c)(1) of the Crown Pastoral Lands Act

subject to s24(c)(1) of the crown rastoral tunds net 1998 the preliminary proposal should be reviewed "to make easier the securing of public access to and enjoyment of the area." Public access should be maintained to the boulders for rock climbers, walkers, geologists, artists, and anyone with an interest in conservation as well as the general public. I support protecting the land around the boulders to keep it in Crown ownership thereby preserving public access.

This is the only area of easy access in the Mackenzie Basin that contains a large number of quality climbing boulders and is popular among many climbers who have used these boulders over a significant period of time. The boulderfield begins right next to the state highway and a number of the larger boulders have been equipped with top rope anchor points for groups of beginner climbers. The boulders are documented in the New Zealand Alpine Club's climbing guidebook to the local area. To wander in the boulder clad valley is an experience many people do and would enjoy given the significant inherent values present- particularly the iconic landscape values.

Further to the above concerns this submission requests that the Preliminary Proposal for Maryburn be withdrawn as it fails to protect the extensive Maryburn outwash plain, the moraines between Lake Pukaki and Mary Range, the eastern slopes of Mary Range, Mary Burn Stream and wetlands, and the Northern wetland which have been identified by expert botanists, entomologists, ecologists and Department of Conservation Staff as having outstanding significant inherent values (siv's) that warrant protection as public conservation land (or covenant)under the objects of the Crown Pastoral Lands Act, (CPLA).

The specific aspects of the proposed preliminary proposal that do not meet the objects of the Crown Pastoral Lands Act include: Maryburn outwash plain - Conservation Area

The triangle of land between SH8 and Tekapo River warrants protection as Conservation land to protect the full range of significant species occurring on the nationally rare basin floor and its significant landscape.

The area proposed for a Sustainable Management Covenant (SMC) should be included as Public Conservation Land as it contains dryland species and systems that compliment the adjoining area.

Lake Pukaki and crest of Mary Range – including Pukaki lateral moraine – Conservation Area

This 1,293ha area of moraine warrants protection as public conservation land for its important values including the nationally significant terminal moraine site, threatened plants and remnant shrublands on low hill country, stony fans and terraces, kettle holes and turf communities Eastern Slopes Mary Range – Landscape Covenant

This area requires a landscape covenant to protect the outstanding landscapes as it is relatively unmodified with few structures and a significant feature when viewed from the SH8.

Mary Burn Stream and wetlands

This area requires protection as a conservation area as it is habitat for threatened long finned eel, koaro, black fronted tern black stilt, and banded dotterels. Northern wetland

The Murrays have faithfully farmed the Maryburn Station for more than 50 years. This has been done during the time of low farmgate returns and high costs associated with weed and pest controls There is no doubt that without farming, this property like many others, would be in a much poorer state. To combat the ravages of weed and rabbit invasions this country <u>needs</u> farmers and farmed animals to counter the invasiveness of these problems

There is a good balance of land going into Crown ownership.

In doing this farm plan a compromise has been reached by both parties, the crown and the tenant. This outcome leaves a viable unit to farm while protecting those values that have been identified by the Crown's agencies.

To shut up land and think it will regenerate has been shown to be a wish but not one that comes to being.

An element of grazing is required for the health and well being of flaura and fauna.

Some land under this review is being retired ,fenced and the pest and weed control will be carried out by the applicants. This is a very generous position for the tenants to have taken.

There is an SMC over badly eroded and depleted land.

Because all the identified values are being protected ,or managed ,we believe this proposal is fair and addresses the concerns of all interested parties.

Once again we support the tenure review proposal of the Maryburn station.
