The Preliminary Proposal for Maryburn in my view fails to protect an extensive range of values identiied in various reports These include geomorphological features associated with the glacial and post glacial history of the landscape (outwash features). Wetland habitats and associated rare and threatened species (Mary Burn Stream and wetlands, and the Northern wetland) considered as having outstanding significant inherent values.

The extensive drylands on the property deserve consideration for protection as part of a wider Conservation Park If this does not eventuate at this juncture then the opportunity to protect something with the sense of scale colur and coverage communsurate with the overall sense of spaciousness imparted by the basin risk being lost. Size in this instance does matter!

I am particularly concerned that no shared vision for the Mackenzie Basin has been promoted. The Basin is a national treasure, with so much to loose relative to so little gain if modified for irrigation. The national allowed the hydro scheme to go ahead in the 1950-70's for obvious reasons: We had next to no power, but nowadays we can sell our landscape for overseas currency. An income that is likely to outlast money from milk.

I agree completely with these arguments. I have posted my own addendum to The Wolds submission and I now post the same addendum here as a an expression of my shock and dismay that these proposals by the state are even being considered.

I live in the UK. A similar proposal was attempted here and the correlation is somewhat alarming. Here, the Conservative Government attempted to sell or lease state owned forests to private concerns and charities. The forests exist on state owned land

- that is, land owned by the state on behalf of its citizens. In effect, the state's citizens own the forests and the land. The UK government was told in no uncertain terms to keep their hands off the public's forests.

The public's concerns were expressed in similar arguments to those expressed above.

I regularly visit my home country and on a recent visit was apalled at the degraded state of the South Island indigenous habitat. This is a unique series of environments that must be held for future generations by the State/Crown and not sold off to private interests. From my experiences it seems that the unique indigenous wildlife, habitats and ecology of New Zealand are still not understood by many new Zealanders since the ravages of the past settlers are still being perpetrated today.

This New Zealand environment cannot sustain such industrial activity as is envisaged by recent proposals. It simply cannot sustain such action without a knock-on destructive impact on the land, streams and rivers and flora and fauna. I cite the West Coast carniverous snails debacle as an example.
