I'm a photographer. I am distressed to see green where brown should be. Grass and

dairy cows to not fit into the natural image of the area people come to see. I worry about the loss of habitat of the endemic flora and fauna, which is so vital and unique, especially as we do not yet know what essential part they have to play in the health and survival of our planet. Irrigation that drains our precious rivers when they are already low threatens the life of the fish population and the quality of the water. I wonder if there is a future in drainage channels that only fill when the river levels are high and which flow into natural low lying areas and can be stored for use when the pasture is dry. These wetlands can provide irrigation water when needed without depleting the river levels as well as providing a habitat for water birds and other aquatic life.
