I live in the UK. A similar proposal was attempted here and the correlation is somewhat alarming. Here, the Conservative Government attempted to sell or lease state owned forests to private concerns and charities. The forests exist on state owned land

- that is, land owned by the state on behalf of its citizens. In effect, the state's citizens own the forests and the land. The UK government was told in no uncertain terms to keep their hands off the public's forests.

The public's concerns were expressed in similar arguments to those expressed above.

I regularly visit my home country and on a recent visit was apalled at the degraded state of the South Island indigenous habitat. This is a unique series of environments that must be held for future generations by the State/Crown and not sold off to private interests. From my experiences it seems that the unique indigenous wildlife, habitats and ecology of New Zealand are still not understood by many new Zealanders since the ravages of the past settlers are still being perpetrated today.

This New Zealand environment cannot sustain such industrial activity as is envisaged by recent proposals. It simply cannot sustain such action without a knock-on destructive impact on the land, streams and rivers and flora and fauna. I cite the West Coast carniverous snails debacle as an example.
