#### 5. Summary of Land Status Report:

#### Cattle Flat

A Land Status Report was undertaken by Opus International Consultants Limited on 24 November 1999. This confirms the status of the land as Crown Land under the Land Act 1948, pursuant to section 66 of the Land Act 1948, and registered under section 83 of the Land Act 1948.

The following items were identified for possible consideration in the Context of Due Diligence:

- 1. A 1996 report notes that there are 18 cribs located within the lease adjacent to the Mataura River. Some of the buildings have been there 40 years.
- 2. Section 112 Eyre Survey District is held under CT 54/93 and adjoins the pastoral lease. The owner of this and the lessee of the pastoral lease are the same. As this adjoins and is not within the pastoral lease boundary, no report has been completed for it.
- 3. Section 1 SO 11976 adjoining is the Mataura Range Scenic Reserve.
- 4. The right-of-way defined and shown on SO 11976 has not been created.

#### The Henroost

A Land Status Report was undertaken by Opus International Consultants Limited on 24 November 1999. This confirms the status of the land as Crown Land under the Land Act 1948, pursuant to section 66 of the Land Act 1948, and registered under section 83 of the Land Act 1948.

The following items were identified for possible consideration in the Context of Due Diligence:

- 1. Section 1 SO 11976 adjoining is the Mataura Range Scenic Reserve
- 2. This lease expired in 1997 and a renewal has no yet been registered.
- 3. SO Plan 11976 is approved for Leasing Purposes only, therefore this plan is not adequate for issue of a crown grant title.
- 4. Marginal strips along rivers and streams that have an average width of not less than 3 metres have not been defined on any plan.

#### 6. Review of topographical and cadastral data:



#### Cattle Flat

- No transmitter sites are shown
- Marginal strips are shown as existing along Tomogalak Stream, Dome Creek and the Mataura River.
- Fenced boundaries appear to follow legal boundaries where they exist. Boundaries are fenced except where the boundary is: a watercourse; Tomogalak Stream; Dome Creek; and the Mataura River. There is no fence line against the southern boundary of the Mataura Range Scenic Reserve.
- Ardlussa Cattle Flat Road is a formed legal road. There are no other legal roads affecting the property.
- There are no known historic sites identified within the property.
- An existing airstrip accessible by track is identified on the topographic map, 2 kilometres southwest from the land identified as water race.

#### The Henroost

- No transmitter sites are shown.
- Fenced boundaries appear to follow the legal boundaries.
- The property is an isolated block and physical access is through adjoining properties.
