ANALYSIS OF SUBMISSIONS

Introduction

Each of the submissions received has been reviewed in order to identify the points raised and these have been numbered accordingly. Where submitters have made similar points these have been given the same number.

The following analysis:

- 1. Summarises each of the points raised along with the recorded number (shown in the appended tables) of the submitter(s) making the point.
- 2. Discusses each point.
- 3. Recommends whether or not to **allow** the point for further consideration.
- 4. If the point is **allowed**, recommends whether to **accept or not accept** the point for further consideration.

The points raised have been analysed to assess whether they are matters that are validly-made, relevant to the tenure review and can be properly considered under the Crown Pastoral Land Act 1998 (CPLA). Where it is considered that they are, the decision is to **allow** them. Further analysis is then undertaken as to whether to **accept or not accept** them.

Conversely where the matter raised is not a matter that is validly-made or relevant or can be properly considered under the CPLA, the decision is to **disallow**. The process stops at this point for those points disallowed.

The outcome of an **accept** decision will be that the point is considered further in formulation of the draft SP. To arrive at this decision the point must be evaluated with respect to the following:

The objects and matters to be taken into account in the CPLA; and

Whether the point introduces new information or a perspective not previously considered; or

Where the point highlights issues previously considered but articulates reasons why the submitter prefers an alternative outcome under the CPLA; or

Is a statement of support for aspects of the Preliminary Proposal which can be considered by the Commissioner when formulating the designations for a Substantive Proposal.

How those accepted points have been considered will be the SUbject of a Report on Public Submissions which will be made available to the public. This will be done once the Commissioner of Crown Lands has considered all matters raised in the public submissions in formulating a Substantive Proposal.

Rationale for Allow

The protection of SIVs is one of the objects of the Crown Pastoral Land Act (Section 24(b)). The method of protection is an alternative to be considered under Section 24(b) and therefore the point is allowed.

Rationale for Accept

While the form of protection was considered during the preparation of a preliminary proposal, the submitters have introduced new information that indicates that this point should be revisited during consultation leading to a draft substantive proposal. Therefore the point has been accepted.

Rationale for Allow

The protection of SIVs is one of the objects of the Crown Pastoral Land Act (Section 24(b». In conjunction with the form of protection sought, a grazing concession can be considered under Section 36(1)(a). The point is therefore allowed.

Rationale for Accept

The alternative of a grazing concession over conservation land for the area identified as CC5 was not considered during the preparation of the preliminary proposal. This is therefore new information and the point is accepted for consideration in preparing a draft substantive proposal.

Rationale for Allow

The point relates to the protection of SIVs as in the point above and the mechanisms for protecting this are also able to be considered under the Act. The point is therefore allowed.

Rationale for Accept

The alternative of a sustainable management covenant for CC5 was not considered during the preparation of the preliminary proposal. This is therefore new information and the point is accepted for consideration in preparing a draft substantive proposal.

Rationale for Allow

The point relates to the protection of significant inherent values using a protective mechanism which is one of the objects of Part 2 Crown Pastoral Land Act. The point is therefore allowed.

Rationale for Not Accept

The point has not been accepted as the matter was considered in the preparation of the preliminary proposal and it was considered that there were inadequate significant inherent values to justify such inter-connection. No new information has been provided.

Rationale for Allow

The point relates to the protection of significant inherent values via a protective mechanism which is an object of Part 2 Crown Pastoral Land Act. The point is therefore allowed.

Rationale for Not Accept

The point has not been accepted as the matter was fully traversed during the preparation of the preliminary proposal and significant inherent values were not identified in the area that would connect the covenant and the conservation area.

Rationale for Allow

The point raised relates to the protection of SIVs and in particular protection of SIVs in an altitudinal sequence from the Cluden Stream to the crest of the Dunstan Mountains. As the protection of SIVs is a matter for consideration under Part 2 Crown Pastoral Land Act the point is therefore allowed.

Rationale for Accept

The protection of this area of the property was considered during the preparation of the preliminary proposal. However a number of submitters have provided information in relation to the SIVs in this area that extends previous information provided in the conservation resources report. The benefits of an altitudinal sequence are also further elaborated by the submitters. The point is therefore accepted for consideration during the preparation of a draft substantive proposal.

Rationale for Allow

This is an alternative to Point 4 as discussed above and the same rationale applies.

Rationale for Allow

The point relates to the provision of public access which is an object of Part 2 Crown Pastoral Land Act. Therefore the point is allowed.

Rationale for Not Accept

We note that under the preliminary proposal as advertised, foot access is provided between the two conservation areas. The submitter did not provide any information in relation to the statement made. There is therefore no new information to be considered in the preparation of a draft substantive proposal. The point has therefore not been accepted.

Rationale for Accept

The point has been accepted as the submitters have raised new information in relation to the SIVs of this area that will be considered in the preparation of the draft substantive proposal. One of the submitters also seeks further elaboration of the values within the covenant document (see point 16.1).

Rationale for Allow

The point relates to the promotion of management of reviewable land in a way that is ecologically sustainable which is a matter to be considered under Part 2 Crown Pastoral Land Act. The point is therefore allowed. This point also closely relates to Point 22 discussed subsequently.

Rationale for Not Accept

The location of the upper level of the freehold was very carefully discussed and considered during the preparation of the preliminary proposal. No new information has been provided by the submitter which would cause this matter to be revisited and the point is therefore not accepted.

The point supports the current preliminary proposal and should be taken into account in the development of a draft substantive proposal. The point is therefore accepted.

Rationale for Allow

The point relates to the protection of SIVs which is an object of Part 2 Crown Pastoral Land Act and is therefore allowed.

Rationale for Accept

The point is accepted as there is new information (in particular game bird habitat and shrublands equivalent of the other covenanted areas) introduced by the submitters which should be considered in the development of the draft substantive proposal.

This point relates to the provision of pUblic access which is an object of Section 24(c)(i) Crown Pastoral Land Act, therefore the point is allowed.

Rationale for Accept

This is a statement of support for the provisions currently contained in the easement which formed part of the preliminary proposal and is accepted for consideration in the preparation of designations for a draft substantive proposal.

Rationale for Disallow

While the point may relate to an aspect of public recreation it has been understood that game shooting is neither an SIV nor an access issue as considered by Section 24 Crown Pastoral Land Act. The point has therefore been disallowed.

Rationale for Allow

The submitters record their support for the proposed access provisions of the preliminary proposal, which is in accordance with the object under Section 24(c)(i) Crown Pastoral Land Act. The point is therefore allowed.

Rationale for Accept

This is a statement of support for a component of the preliminary proposal which will be noted in the preparation of the draft substantive proposal. The point is therefore accepted.

Rationale for Allow

The point relates to the provision of public access which is an object of Part 2 Crown Pastoral Land Act and is therefore allowed.

Rationale for Not Accept

The matter was fully traversed during the preparation of the preliminary proposal and the decision to restrict the seasonal access by vehicles was made on the grounds of public

safety, track maintenance and disturbance to adjacent land use. No new information has been provided that would cause this decision to be revisited.

Rationale for Allow

The point concerns the enabling of protection of significant inherent values relating to the recreational use of the land which is an SIV for the Commissioner to consider under the Crown Pastoral Land Act. The point is therefore allowed.

Rationale for Accept

This is a matter that has not previously been considered and warrants consultation with DoC to confirm whether the existing clauses confer rights to Fish and Game or whether an additional clause is required. The point is therefore accepted.

Rationale for Allow

The point relates to the protection of SIVs which is an object of Part 2 Crown Pastoral Land Act. The point is therefore allowed.

Rationale for Not Accept

It is noted that the conservation area CA1 is approximately triangular in shape with two of the boundaries currently fenced and the designations plan clearly showing a proposal to fence the third boundary. It would appear that the submitters have misinterpreted the designations plan. The information supplied is therefore not new information, and the point is therefore not accepted.

Rationale for Allow

The point relates to the protection of SIVs which is an object of Part 2 Crown Pastoral Land Act. The point is therefore allowed.

Rationale for Not Accept

It is noted that conservation area CA2 is either currently fenced or has fencing proposed as outlined in the preliminary proposal. It would therefore appear that the submitter has misinterpreted the designations plan. The submitter has not added any new information relating to the desirability of fencing this area, and therefore the point is not accepted.

The submitter has acknowledged that if CA1 is extended there will be an additional need for stock movement access as the property will be divided by this extension. There is provision in the Crown Pastoral Land Act pursuant to Section 36(1)(a) and Section 36(3)(b) for granting such concessions/easements. The point is therefore allowed.

Rational for Accept

As the extension of CA1 had not been formally considered in the preliminary proposal the aspect of stock movement in relation to this was not addressed. The submitters have therefore identified new information in this regard, and the point is therefore accepted for consideration in the preparation of a draft substantive proposal.

Rationale for Allow

The point relates to the protection of SIVs and addresses the issue of the form of protection to be provided. This matter is covered by Section 24(b) Crown Pastoral Land Act and is therefore allowed.

Rationale for Accept

In making this point the submitters have introduced new information relating to the significance of identified inherent values that was not considered during the preparation of the preliminary proposal. The point is therefore accepted.

Rationale for Allow

The point relates to the protection of significant inherent values under a protective mechanism which is an object of Part 2 Crown Pastoral Land Act. The point is therefore allowed.

Rationale for Accept

The point refers to previously considered information, however the submitter articulates reasons for enhancing the documentation. The point has been accepted as the description of the values could be enhanced in the document.

The matter relates to the protection of SIVs which is an object of Part 2 Crown Pastoral Land Act and is therefore allowed.

Rationale for Accept

The submitters have introduced new information relating to SIVs on the periphery of the current CC6 which need to be taken into account during the preparation of the draft substantive proposal. The point is therefore accepted.

Rationale for Allow

This point relates to the protection of SIVs within the covenanted areas. As the protection of SIVs is an object of Part 2 Crown Pastoral Land Act the point is allowed.

Rationale for Not Accept

The submitters have not introduced any new information and therefore the point is not accepted. Any monitoring of any covenants is already a requirement of conservation management and therefore this point is also not accepted.

Rationale for Allow

This point relates to the protection of SIVs within the covenanted areas. As the protection of SIVs is an object of Part 2 Crown Pastoral Land Act the point is allowed.

Rationale for Not Accept

The design of the covenant areas was carefully considered during the preparation of the preliminary proposal and due to natural features it was considered inappropriate to fence these areas. The submitters have not introduced any new information in relation to this and therefore the point is not accepted.

While this point was not directly related to the protection of SIVs or the objects of Part 2 Crown Pastoral Land Act it is however a component of a protective mechanism issued under Section 40(2)(a) Crown Pastoral Land Act. It therefore is a matter to be considered and the point is therefore allowed.

Rational for Accept

The provision of access through the proposed covenants was a matter considered in the preparation of the preliminary proposal however the submitters have raised significant matters in relation to the effect of a wide access way through the covenant and have requested a review of the width of these access ways. This new information therefore requires consideration in the preparation of a draft substantive proposal and the point is accepted.

Rationale for Allow

This point relates to the protection of SIVs within the covenanted areas. As the protection of SIVs is an object of Part 2 Crown Pastoral Land Act the point is allowed.

Rationale for Not Accept

The design of the covenant areas was carefully considered during the preparation of the preliminary proposal and due to natural features it was considered inappropriate to fence these areas. The submitters have not introduced any new information in relation to this and the point is therefore not accepted.

Rationale for Allow

The point is allowed as the protection of SIVs which is the purpose of CA2 is an object of Part 2 Crown Pastoral Land Act.

Rationale for Accept

The support for the conservation area CA2 is noted and this proposed conservation area will be carried forward to the preparation of the draft substantive proposal. The point is therefore accepted. Note that the consideration of extensions to CA2 is considered elsewhere in this analysis for example points 1, 3, 4, 4.1, and 16.

Concession easements are a consideration under Section 36 Crown Pastoral Land Act and therefore the point is allowed.

Rationale for Accept

These concession easements form part of the preliminary proposal and the information will continue forward to the preparation of the draft substantive proposal. The point is accepted as a statement of support.

Rationale for Allow

The proposed historic reserve protects SIVs which is an object of Part 2 Crown Pastoral Land Act therefore the point is allowed.

Rationale for Accept

The proposed historic reserve has been identified in the preliminary proposal and will carry forward to the preparation of the draft substantive proposal. The point is accepted as a statement of support.

Rationale for Allow

The point relates to the management of Crown land in a manner that is ecologically sustainable and also the protection of SIVs. Both are objects of Part 2 Crown Pastoral Land Act and the point is therefore allowed.

Rationale for Accept

While the boundary of CA2 was carefully considered during the preparation of the preliminary proposal, the submitters have provided more specific information in relation to the SIVs present in the mid-altitude land than was possible in the CRR, in particular over the land above 1000m. The relevance of this information needs to be considered in the preparation of a draft substantive proposal. The point is therefore accepted.

A conservation covenant is a protective mechanism under the Crown Pastoral Land Act and relates to the protection of SIVs which is an object of Part 2 Crown Pastoral Land Act. The point is therefore allowed.

Rationale for Accept

While the design of CC2 was carefully considered during the preparation of the preliminary proposal, the submitters have introduced new information in relation to the extent of the SIVs in this location including *Galaxid* populations that should be considered in the preparation of the draft substantive proposal. The point is therefore accepted.

Rationale for Allow

A conservation covenant is a protective mechanism under the Crown Pastoral Land Act and relates to the protection of SIVs which is an object of Part 2 Crown Pastoral Land Act. The point is therefore allowed.

Rationale for Not Accept

The design of the conservation covenants was carefully considered during the preparation of the preliminary proposal. In this case the submitter has not introduced any new information for consideration and the point is therefore not accepted.

Rationale for Allow

A conservation covenant is a protective mechanism under the Crown Pastoral Land Act and relates to the protection of SIVs which is an object of Part 2 Crown Pastoral Land Act. The point is therefore allowed.

Rationale for Accept

While the design of CC1 was carefully considered during the preparation of the preliminary proposal the submitter has introduced new information in relation to the habitat of rare moths that should be considered in the preparation of the draft substantive proposal. The point is therefore accepted.

The point relates to the protection of significant inherent values which is an object of Part 2 Crown Pastoral Land Act and the point is therefore allowed.

While the boundaries of CC4 were considered to protect SIVs at the time of the preliminary proposal, the submitters have provided new information as to the extent of the SIVs. The point is therefore accepted for consideration in the preparation of a draft substantive proposal.

Rationale for Allow

The recognition of and protection of historic sites is an SIV to be considered within the objects of Part 2 of the Crown Pastoral Land Act and the point is therefore allowed.

Rationale for Accept

The conservation resources report provided very limited data on heritage values in relation to this lease. Noted in the report were only two European sites relating to stone stock yards that had been removed and a stone hut ruin. The Historic Places Trust have also identified the Richmond Hut as being a likely archeological site, potential Chinese association with Archie's Flat, a significant water race on the north side of Cluden Stream, as well as the two sites previously shown. This is additional information in relation to the historic sites on the property and the point is therefore accepted for consideration in the preparation of the draft substantive proposal.

Summary and Conclusion

Overview of analysis

In analysing the 13 submissions received, 72 points were identified. Within these 72 points there were 48 distinct areas of interest that were identified and the points have been grouped accordingly. Of the 72 points raised 67 were allowed for consideration as they were matters to be considered under the Crowh Pastoral Land Act 1998. Of those 67 points that were allowed 48 points have been accepted for consideration in the preparation of a draft substantive proposal. This was largely on the basis of the provision of new information however it is noted that of those 48 points accepted 14 were of qualified support to aspects of the proposal. These points were accepted as it was recognised that this information should be considered in the context of the other 34 points that require further consideration.

Generic issues

The key points for further consideration in the preparation of a draft substantive proposal relate to inter-connectivity of the various protected areas. Strong support was expressed for connecting CA1 and CA2 via an altitudinal sequence. Similar s'upport was expressed for

incorporating CC5 and CC6 into the Conservation area. Other points related to some fine tuning of the access provisions.

Gaps identified in the proposal or tenure review process

While some submitters felt that the preliminary proposal fell short of meeting the objects of . Part 2 Crown Pastoral land Act, no specific gaps were identified in the process followed to date. The submitters have provided additional information that will assist in the development of the draft substantive proposal which is an outcome of the public process.

Risks identified

No specific risks have been identified through the public notification process.

General trends in the submitters' comments

These are outlined in the earlier heading under generic issues.
