- A recreation permit [File: RPo/064-SDN-01] was issued to Nic Kagan Guiding over the Glenaray Pastoral Lease in 1998 for a term of 1 year allowing for guided ski tours. This permit has now expired, and there is no indication that any activity continued beyond expiry.
- A recreation permit [File: RPo/053-SDN-01 & 02] was issued to RW and SL Brown over the Glenaray Pastoral Lease for a term of 12 years from 1 October 1998 allowing for motorised ski tours.

4. Summarise any Government programmes approved for the lease:

A Land Improvement Agreement was approved for the lease in 1976 to assist and mitigate erosion over the Lease. Works involved fencing and tracking and the imposition of block grazing limits on particularly erosion prone areas. Work ceased on this plan in 1979, however it was agreed to resume the Plan in 1984. File records indicate that the works were completed as per the revised Agreement.

5. Summary of Land Status Report:

Opus International Consultants Limited undertook a Land Status Check on 28 June 2002. This check confirms the status of the Land as Crown Land under the Land Act 1948 subject to Pastoral Lease Ps008.

The following items were noted for information:

- A field inspection may be required to ascertain if streams within this pastoral lease could be subject to Section 24 of the Conservation Act 1987. The Crown Land reserved from sale section 58 Land Act 1948 along the banks of the Waikaia River, Blue Lake Creek, Gorge Creek, Welshmans Creek and around an unnamed Lake are now deemed to be marginal strips of the same width (section 24(3) Conservation Act 1987) the boundaries of the marginal strips do not change (section 24G(7) Conservation Act 1987).
- Allocation D*F43*24*CO(SO11177) of stewardship land to the Department of
 Conservation pursuant to section 62 of the Conservation Act 1987 is in conflict with
 other documentation. The allocation schedules show the land was allocated as
 "parts Waikaia State Forest". This portion of land is shown on SO 8342 as part of
 Run 626, therefore the land is part of this pastoral lease and was not available for
 allocation to the department.
- This lease is subject to two Land Improvement Agreements pursuant to the Soil Conservation and Rivers Control Amendment Act 1959. The document reference for one of these is unclear on the lease document.
- This lease has not been converted into Landonline.
