Variation

In consideration of the obligations of the parties under this Deed of Variation, the parties agree that the proposal for review of Crown land under part 2 of the Crown Pastoral Land Act 1998 put by the Commissioner of Crown Lands to the Holder dated 5 March 2009 ("the Proposal") is hereby varied as follows:

1. Clause 1.1 of Schedule Three of the Proposal is hereby varied by the inclusion of a new sub-clause (I) which reads:

"(I) the continuation in force of 976715.1 Certificate under Section 417 Resource Management Act 1991 which is deemed to create in favour of the permit holder an interest in land pursuant to Section 417 (4) (a) of the Resource Management Act 1991 as set out in Appendix 14".

2. Clause 1.1 of Schedule Three of the Proposal is hereby varied by the inclusion of a new sub-clause (m) which reads:

"(m) the continuation in force of 5076753.1 Mining Certificate No's 40P and 47P, Pembroke Registry, pursuant to Section 417 Resource Management Act1991, which is deemed to create in favour of the permit holder an interest in land pursuant to Section 417 (4) (a) of the Resource Management Act 1991 as set out in Appendix 15".

3. New Appendices 14 and 15 in the form attached hereto are hereby added to the Proposal.

General

Except as varied hereby, the provisions contained or implied in the Proposal shall remain in full force and the parties mutually agree that they will comply with them.

Pursuant to Section /417(2) of the Resource Management Act 1991, the Otago Regional Councilhereby certifies that

Colin Francis Clark, Tarras, Central Otago

being registered as holder of Licence for a Water Race No. 9973, Cromwell Registry of the Warden's Court, are entitled to cut, construct, and maintain a race, to use as a race a natural channel (but only where that channel has been so used under the licences), to occupy (but only for the purposes of the construction, maintenance, and improvement of the race) the land forming the course of the race plus a strip 6.1 metres wide (20 feet) along the entire length of the race, and measured either wholly on one side of its course or partly on one side and partly on the other, so that the total on both sides does not exceed 6.1 metres to deposit within those strips any material removed from the race in the course of maintaining and improving it, and to convey water in the race, across the lands described in the Schedule, as indicated on the attached diagram.






