The Grantee gives notice under Section 61 of the Crown Pastoral Land Act 1998 (the **Act**) that the Holder has on the 8th day of September 2011 accepted (in accordance with Section 60 of the Act) a Substantive Proposal relating to the land in the above Computer Interest Register ("the land")

The Substantive Proposal provides for the following designations in respect of the land:

- (a) 857.6166 hectares (approximately) to be designated as land to be restored to or retained in full Crown ownership and control as Conservation Area pursuant to Section 35(2)(a)(i) of the Act;
- (b) 15.4000 hectares (approximately) to be designated as land to be restored to or retained in Crown control as Conservation Area pursuant to Section 35(2)(b)(i) subject to qualified designations under Sections 36(1)(a) of the Act being easement concessions for farm management purposes;
- (d) 960 hectares (approximately) to be designated as land to be disposed of by freehold disposal to the Holder pursuant to Section 35(3) of the Act, subject to:
  - Part IVA of the Conservation Act 1987:
  - Section 11 Crown Minerals Act 1991;
  - Conservation Covenants under Section 77 of the Reserves Act 1977;
  - Public access and Management Purposes Easements under section 7(2) of the Conservation Act 1987.
