# 3. Summary of lease document:

#### Terms of lease

There are no special provisions in the lease.

#### Area adjustments

The total area shown in CL 6A/1438 is incorrect. Incorporation Certificate (058155.1) formalises the current land within the lease. It does not take the form of an addition of land.

#### Registered interests

#### Compensation Certificate

Compensation Certificate 012676.1 registered on the lease pursuant to section 17 of the Public Works Amendment Act 1948, notifies of the Crowns intention to acquire 3 hectares approximately together with access for a microwave site on Mount Prospect. A title has been raised in the name of Telecom New Zealand Limited to the microwave site, but the access does not appear to have been legalised. SO 11957 defines the access easements. Correspondence recorded on the file from 1996 notes that it was intended to create the easement immediately following the creation of title to the land. This has not occurred.

#### Land Improvement Agreement

A Land Improvement agreement was entered into between the lessee and the Southland Catchment Board pursuant to the Soil Conservation and Rivers Control Amendment Act 1959, and is registered against the lease as memorial 285176. The agreement outlines a programme of fencing, cultivation, over sowing and topdressing.

# 4. Summarise any Government programmes approved for the lease:

Other than the Land Improvement Agreement referred to above, there are no known Government approved programmes for this lease.

### 5. Summary of Land Status Report:

A Land Status Report was undertaken by Opus International Consultants Limited on 15 November 2000. This confirms the status of the land as Crown Land under the Land Act 1948, pursuant to section 66 of the Land Act 1948, and registered under section 83 of the Land Act 1948.

The following items were identified for possible consideration in the Context of Due Diligence:

- 1. The total area shown in CL 6A/1438 is incorrect. The Incorporation Certificate (058155.1) only formalises the current land within the lease. It does not take the form of an addition of land.
- 2. It is noted that there is a variation in the north eastern boundary between the survey plan for the lease (SO 8645) and plan defining the adjoining conservation area (Sec 5 SO 12090). Terraview shows the boundary of the Mount Prospect lease based in definition of the conservation plan SO 12090 but this is not supported by legal documentation, that is a certificate under section 113 of the Land Act 1948. The plan for this status check shows the definition of the lease as shown in the cadastral record.
- 3. A field inspection may be required to ascertain if Moat Creak, and other streams within this pastoral lease could be subject to section 24 of the Conservation Act 1987. No evidence has been found that this aspect was considered on renewal of this lease on 1 July 1993. A letter to DOSLI dated 4 September is on file requesting advice on this aspect, however no reply has been found.

- 4. The Crown Land Reserved from Sale under section 58 of the Land Act 1948 along the Whitestone River, and around Lake Thomas is now deemed to be a marginal strip of the same width (s24(3) Conservation Act 1987 effective date 10/4/1990). The boundaries of the marginal strip do not change (s24G(7) Conservation Act 1987).
- 5. Compensation certificate (12676.1) action is incomplete. The agreement requires access to be supplied by right of way, this has not been formalised. Refer to SO 11957.

## 6. Review of topographical and cadastral data:

A review of the topographical plans attached to the Land Status Report identifies the Telecom site surrendered from the lease and the access to the site which has not been formalised.

The topographic map indicates there is an airstrip towards the north of the property, just south of the formed road to the Telecom site at the top of Mount Prospect.

No other facilities were identified on the plans.

Incorporation Certificate [058155.1] only formalises the land contained within this lease, the area of the lease doesn't change.
- It is noted that there is a variation in the northeastern boundary between the survey plan for the lease [SO 8645] and plan defining the adjoining Conservation area [Sec 5 SO12090]. Terraview shows the boundary of the Mt Prospect lease based on definition of the conservation plan SO 12090 but this is not supported by legal documentation ie a Certificate under Section 113 Land Act 1948. The plan for this status check shows the definition of the lease as shown in the cadastral record.
