#### Unregistered interests

Part of the lease is covered by Prospecting Permit 39/143, held by Macraes Mining Company Limited, under the Crown Minerals Act 1991. The permit is registered as OT9D/622, however, this has not been recorded against the lease. This licence expired on 26 February 2001, however, the licence holder has submitted an application to Crown Minerals, Ministry of Economic Development for an extension of the duration. A special interim extension has been granted while their application is being processed.

There are no other unregistered interests recorded on the file.

#### 4. Summarise any Government programmes approved for the lease:

Former lessees entered into two Land Improvement Agreements under the Soil Conservation and Rivers Control Act 1941. Both agreements were registered against the title in 1980. Agreement 517989 outlines a course of Government subsidies for erosion control fencing and cattle proofing. Agreement 543709 outlines a course of Government subsidies for erosion control fencing and aerial top dressing and oversowing.

#### 5. Summary of Land Status Report:

Opus International Consultants Limited undertook a Land Status Report on 30 November 2000. This confirms the status of the land as Crown Land under the Land Act 1948, pursuant to section 66 of the Land Act 1948, and registered under section 83 of the Land Act 1948.

The following items were identified for possible consideration in the Context of Due Diligence:

- 1. A field inspection may be required to ascertain if streams within this pastoral lease could be subject to Section 24 of the Conservation Act 1987. No evidence has been found that this aspect was considered on the creation of this lease on 1 July 1969. The Crown Land Reserved from Sale under section 58 of the Land Act 1948 along Kauru and Waianakarua (North Branch) Rivers is now deemed to be a marginal strip of the same width (section 24(3) Conservation Act 1987, effective date, 10/4/1990). The boundaries of the marginal strip do not change (section 24G(7) Conservation Act 1987).
- 2. Prospecting Permit 39/143 under the Crown Minerals Act 1991 covers part of this lease. The permit holder is the Macraes Mining Company Limited. The permit is for a period of two years commencing in 26 February 1999, and is registered as OT9D/622 [Otago Registry].

#### 6. Review of topographical and cadastral data:

A review of the topographical and cadastral plans attached to the Land Status Report reveals that there are no long distance transmission lines, communication sites, or other facililities on the property.

There is an airstrip which crosses onto the property along Tulliemet Road.

There is a hut at the end of Tulliemet Road.
