GENERAL . DESCRIPTION:

Altitude ranges from 2000 to 4700 ft. The country has a westerly aspect, broken by steep gullies, but generally well balanced for winter and summer country. Cover consisting mainly of tussock, native grasses and snow grass has suffered owing to heavy infestation of rabbits in the past.

The Run is subdivided into three blocks.

ACCESS:

The run is separated from the freehold by a block of land owned by W. Hogg. The shortest distance between the two properties is half a mile. Access to the freehold is good, but from this point to the run, a distance of approv-4 miles is little better than a grass track and is not suitable for motor transport.

Run has suffered from rabbits in the past. have had years of experience with rabbits and in cooperation with the Rabbit Board excellent work has been done.

The present state is that the rabbits have been reduced a minimum and cover is definitely on the improve. will take some years to completely recover, but under the present system of rabbiting plus controlled stocking and burning reduced to a minimum, there is no doubt that the country will be restored to a healthy state.
