### 2. Background Information

This report has been prepared on the instruction of Land Information New Zealand in terms of the Statement of Work dated 25 March 2013 and is undertaken for the purpose of updating the current Land Status Report for The Wandle. This assessment has been undertaken in accordance with the requirements of LINZS45000: Standard to Determine Authority to Act and Record Crown Land.

Where changes to the Land Status Report have been identified, the relevant changes and supporting documentation are attached to this report. The Land Status Plan has been updated in accordance with the requirements of LINZ's Drawing Specifications for Land Status Plans.

Any changes identified from our review of the Land Status Report shall form an addendum to the report dated 3 November 1999. A new Land Status Report has not been prepared.

**Uncompleted Actions:** 

SO 23303 was compiled in office by the Department of Survey and Land Information in March 1990 and approved as to survey on the 7 October 2002. This plan is a re appellation of the underlying parcels contained within the lease and created a new appellation for the lease being, Section 1 5O 23303. This survey defined the lease area as being 1273.6170 hectares. Land on Line has been updated to reflect the new appellation and area, but the lease and CIR have

currently not been updated to reflect these changes.

### 4. Discussion

The land status report for The Wandle, as prepared on the 3 November 1999 (as attached in Appendix 2) by Opus International Consultants Ltd, was used as the basis of this addendum. A review of the data used in this initial report has been undertaken and an investigation of unregistered transactions and transactions registered against Computer Interest Register OT4C/757 since the completion of the initial report has also been completed.

As a result of SO 23303 a number of existing land parcels where extinguished with land being contained within the lease given a new appellation by SO 23303. This has not been reflected in the changes to the lease listed on the CIR resulting in a number of parcels appearing on the face of the CIR that no longer exist and the newly created parcel not being defined on the CIR or lease. The current legal description is listed above. This survey being the most accurate survey information for the lease defines the land area as being 1273.6170 hectares. This area should also be reflected in the lease and CIR as being the true land area.

#### 5. Reference Material

Computer Freehold Registers used in the determination of the status of The Wandle are attached in Appendix 1. Additional reference material is attached in Appendix 3. Current files held by LINZ in Christchurch relating to The Wandle have also been searched.

# 6. Recommendation

That the land depicted on the attached plan be accepted as having status as Crown Land subject to the Land Act 1948, and that the land depicted on the attached plan be accepted as being subject to Lease PO 328 as contained in Computer Interest Register OT4C/757.

It is recommended that the CIR be updated to truly reflect the current parcels and area.
