Introduction

The Royal Forest and Bird Protection Society (Forest and Bird) is New Zealand's oldest and most active voluntary conservation organisation. Formed in 1923 the Society has around 38,000 members in 56 branches around New Zealand. This submission is on behalf of the Central Office. The Society's constitution requires it to:

"take all reasonable steps within the power of the Society for the preservation and protection of indigenous flora and fauna and natural features of New Zealand for the benefit of the public including future generations."

"Protection of natural heritage includes indigenous forests, mountains, lakes, tussocklands, wetlands, coastline, marine areas, offshore islands and the plants and wildlife found in those areas."

This submission is based on analysis of the "Summary of the Preliminary Proposal" prepared by Q. V. Valuations, the "Conservation Resources Report" prepared by the Department of Conservation and a site visit by Forest and Bird on 29 January 2004

Proposed Conservation Areas CA 1 and CA 2

CA 1 and CA 2 contain significant remnants of mountain beech forest, mixed broadleaf forest in the gullies and extensive blocks of regenerating kanuka shrublands over much of the area. On the higher slopes where exotic grasses do not dominate they also contain increasing amounts of fescue tussock, snow tussock and native herbs and shrubs as the altitude increases.

Grey Hill and the south faces overlooking the Waiau River dominate the landscape when viewed from State Highway Seven across the river. The addition of these blocks to the adjoining Hanmer Forest Park will protect the landscape values and provide potential for more easily accessible recreation opportunities in the area.

ROYAL FOREST AND BIRD PROTECTION SOCIETY OF NEW ZEALAND INC Forest and Bird supports the creation of the CA 1 and CA 2 conservation areas and agrees with proposed boundaries.

Public Access

Forest and Bird supports the creation of the proposed easement a-b-c-d to facilitate public access to the new conservation areas and the adjoining forest park, however we are concerned that access to the start of these easements at points b and c, and to other parts of CA 1 between V and W, is not secure. We note that separate negotiations are being undertaken outside the tenure review process to secure access across the freehold land that adjoins the lease to the south and is owned by the leaseholder. However if these negotiations are not successful practical public access up the Epsom valley to CA 1 will not be possible.

Decisions Sought

- 1. That the areas CA 1 and CA 2 be restored to full Crown ownership and control, as conservation areas as proposed.
- 2. That the easement a-b-c-d be created for public access as proposed.
- 3. That final agreement between the parties be dependent on securing public access across freehold land along the existing farm roads and tracks to Epsom River and the proposed new easements a-b-c-d and to a point on the CA 1 boundary between points V and W. Access should be for vehicles to the Grantham River and for foot and non-motorised vehicle beyond the river.

Thanks for the opportunity to comment on the preliminary proposal and congratulations on the notification of a proposal that in the main is successful in protecting significant inherent values and improving public access.
