## Overseas Investment Regime: Release of Consultation Document on a Proposed Fee Structure

Portfolio Associate Finance (Hon David Parker)

On 17 February 2021, the Cabinet Economic Development Committee (DEV):

- 1 noted that Land Information New Zealand administers the overseas investment regime, and that existing application fees are not recovering the costs of administering the regime;
- 3
- 4 noted that the Associate Minister of Finance (Hon David Parker) proposes a new fee structure to recover costs, and to:
  - 4.1 introduce a lodgement fee for the quality assurance of applications;
  - 4.2 introduce fees for standard and complex application assessments;
  - 4.3 introduce a monitoring compliance fee for approved applications;
- 5 **noted** the summary of the increase in total fees resulting from the proposed new fee structure and increased fees for the overseas investment regime, attached as Annex A of the paper under DEV-21-SUB-0002;
- **noted** that the consultation document *Review of Third-Party Funding for the Overseas Investment Office: Proposals for a New Fee Structure and Fee Levels* (the consultation document), attached as Annex B of the paper under DEV-21-SUB-0002, outlines the proposed new fee structure and increased fees;
- agreed to the release of the consultation document in late February 2021;
- 8 authorised the Associate Minister of Finance (Hon David Parker) to make minor and editorial amendments to the consultation document, and to determine the precise timing for its release:
