General | Hei korero whānui

1. Karakia | Prayer Whakatau | Welcome

The Board opened the hui with its karakia. The Chairperson welcomed hui participants, especially the three new members, Mahana Toka, Dr Cadence Kaumoana and Iaean Cranwell who had all attended an induction session in August 2023.

3. Agenda | Rārangi take Disclosure of conflicts of interest | He whākinga rongorua

4.1. Previous minutes | Ngā kōrero o te hui o mua

The Board reviewed the draft minutes of its 22 June 2023 hui (Objective ID 5601287). There were no comments or edits from the Board.

The Board noted some minor grammatical errors that will be corrected:

- Page 5, 6.1, first paragraph: bracketed reference to '[apple] phones' to be changed to '[Apple] phones'.
- Page 7, item 6.2, line 5: insert the word 'been' after 'had' to read 'there had <u>been</u> a few very abusive submissions'.
- Page 7, item 6.2, second paragraph— add 'Legal Team' after 'Toitū Te Whenua LINZ'.
- Page 17, end of page: the Secretariat note regarding 'no timeframe' for the Meyer proposals can be deleted because the response has been received.

The current Board members introduced themselves to the three new members and welcomed them to the Board. They acknowledged the Board's important mahi as New Zealand's national place naming authority and spoke of the privilege of being a Board member. A succinct summary of the mahi being thorough and proper processes, with tight and good place name decisions that serve the nation. The three new Board members then introduced themselves. Secretariat member Jill Remnant also introduced herself to the new Board members as she hadn't attended their August 2023 induction session.

Standard decisions | Ngā whakataunga noa

5. Minister's decision | Whakatau a te Minita

The Board noted the information and report provided (Objective ID A5548644). The Board was concerned that it may be up to a year before any new decisions are made. There is likely to be a new Minister for Land Information as a result of the recent elections, and any decision making is reliant on how long it takes for a new government to form and decide on its priorities. It was suggested that if no outstanding decisions have been made by the Minister by the Board's next hui in April 2024, the Board should send a letter to the Minister.

There is an opportunity to advise the Minister of the Board's activities in the BIM (Briefing for the Incoming Minister) which Toitū Te Whenua LINZ produces, but there is no separate BIM for the Board. It may be more effective for the Chairperson to meet with the Minister to discuss the Board and the Minister's role in greater detail.

Actions required

- Board to reconsider its suggestion to write to the Minister on any outstanding decisions not yet made as at the Board's April 2024 hui.
- Chairperson to pursue meeting with the new Minister to advise on the Board's and Minister's roles.

6. Decisions made by Chairperson | Whakatau a te Toihau

The Board noted the information and report provided (Objective ID A5478183). Mahana Toka requested confirmation that the local marae had been engaged for the Rangiriri and Whangamarino decisions and requested copies of the correspondence.

Action required

• Secretariat to provide Mahana Toka with the proposer's correspondence with local marae showing their support of the Rangiriri and Whangamarino proposals.

7. Submissions on proposals | Tāpaetanga ki ngā tono

7.1 Herwin Creek

The Board noted the information and report provided (Objective ID A5551876).

For the benefit of its new members the Board discussed the decision making processes in relation to this proposal, noting that the initial decision that the Board makes when accepting a proposal is important as it means that it initially agrees with the proposal.

7.2 Pūāwhē

The Board noted the information and report provided (Objective ID A5479967). Board member, Shaun Barnett has had the article 'Name Proposal on Pirongia Mountain' published in the Federated Mountain Clubs' Bulletin <u>Backcountry</u>.

The Board noted that the 'āwhē' part of the name isn't a single word –the [ā] is a particle and [whē] refers either to a tree fern or caterpillars.

7.3 Mitiwai Stream

The Board noted the information and report provided (Objective ID A5602469).

Resolutions

The Board **considered** the **five** submissions on the proposal to approve the unofficial recorded name **Mitiwai Stream** as an official place name and their reasons,

and

Rejected the **one** objecting submission that supports the alternative existing unofficial recorded name, Matauwai Stream, based on the reasons provided not outweighing those the Board previously accepted for the proposal and new reasons, being:

- the function of the Board to encourage the use of original Māori place names and advice that 'Mitiwai' is the correct, original name,
- evidence of historical use, including use of Mitiwai Stream on official maps until relatively recently (as late as 1984),
- advice that the name used locally for the feature is Mitiwai Stream, including evidence of continued use in scientific publications,
- support from three local marae and a formal letter of support from Waikato-Tainui,
- approving one of the names as official and replacing the other one potentially benefitting identification to emergency services,
- the use of the alternative existing unofficial recorded name, Matauwai Stream, appears to have been depicted in error on maps since 1984, and
- costs to change the name of the stream on maps and road signs (if there are any) would be negligible, especially for digital updates, and do not outweigh the Board's function to use the original Māori place name,

and

Confirmed the Board's earlier decision to accept the proposal to approve the unofficial recorded name **Mitiwai Stream** as an official place name, and replacing the alternative existing unofficial recorded name, Matauwai Stream.

and

Carried

Will **report** to the Minister for Land Information **and request** the Minister to make the final determination on the proposal.

Further discussion

The Board noted that even when it receives just one objection, if it rejects the objecting submission the proposal still has to be reported to the Minister for a final determination. Because a government hasn't yet formed, the Board agreed that there is no urgency to report the proposals that require a final determination to the Minister.

• Secretariat to report the Board's decision to the Minister for Land Information.

8. Deferred proposals | Tono kua tārewatia

8.1 Mount Paterson and Mount Northcroft

The Board noted the information and report provided (Objective ID A5604367). The two proposals have been deferred for a long time because the features may have original Māori names. The Board has asked TRONT to advise, but to date they haven't responded.

From a safety point of view for mountaineers, there doesn't appear to be any issues for Search and Rescue as the peaks are in a remote area and mountaineers need to be very experienced to even get to the base of the peaks.

The Board discussed whether altering the positions of the names without making them official is an option as the process of the names becoming official might be more concerning to TRONT than the positions being corrected. The Board agreed to continue to defer the proposal, noting that TRONT will address the issue as time allows.

9.55am – Waihoroi Shortland joined the hui in person.

The Chairperson welcomed Waihoroi Shortland and introduced him to the new Board members.

8.2 Meyer Pass, Meyer Creek and Meyer (hill)

The Secretariat provided a summary of the correspondence with TRONT requesting whether they know of an original Māori name for the pass. Te Rūnanga o Waihao has since confirmed that they had no concerns with the proposal proceeding, therefore the proposals had been publicly notified for submissions, to run until 31 October 2023.

8.3. Wellington local use name proposals

The proposer has declined a request to discuss the proposals with the Secretariat and is yet to meet the Board's minimum requirements for his remaining 42 proposals despite having been provided with iwi contact details. The Board noted that the proposals don't have broad public interest and agreed to do nothing proactively as the responsibility is with the proposer.

Action required

• Secretariat to inform the proposer that progress with processing the remaining proposals is dependent on meeting minimum requirements.

9. Name Proposals | Tono taunahatanga

9.1. Franz Joseph / Waiau, Franz Joseph Glacier / Kā Roimata o Hine Hukatere

The Board noted the information and report provided (Objective ID A5504453). The Board noted that it is legally able to change these names under the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008. An earlier legal opinion (provided under the New Zealand Geographic Board Act 1946) advised that the Board was unable to alter existing Treaty settlement place names. The new legal opinion has been discussed with TRONT in terms of the non-Māori part in dual place names, and they have also been advised that the Māori part of the dual names could be subject to submissions should the proposals be notified.

There is an opportunity to align the names with the standard convention that a space be applied to either side of the solidus (forward slash) in dual names. As some of the earliest dual names in the

modern format, the Ngāi Tahu settlement names don't include the space. If Josef was to be changed to Joseph, it wouldn't impact emergency services as the word sounds the same.

TRONT hasn't yet confirmed that they are happy with the orthographic advice to alter the Māori part of the name from Kā Roimata o Hine Hukatere to Kā Roimata-o-Hinehukatere. Paulette Tamati-Elliffe advised that the standard orthographic convention is that hyphens are to be used in names of more than seven syllables, but she wasn't speaking on behalf of TRONT or the rūnanga in terms of their preference. TRONT currently publishes Kā Roimata-a-Hinehukatere in *Kā Huru Manu* with the [a] possessive and the Board wondered if this is a concern. The Board had published the name with the [a] possessive on its Tangata Whenua maps, which appeared to be the preference of the relevant rūnanga.

The Board agreed to the recommendations but with the public notification period to be one month, not three months, because most submissions are typically received at the beginning of the notification period. The recommendations are also subject to TRONT confirming the updated orthography, which the Secretariat will clarify with TRONT.

Resolutions

The Board **declined** the proposal to **alter** the official dual name Franz Josef Glacier/Kā Roimata o Hine Hukatere to **Franz Joseph Glacier / Kā Roimata o Hine Hukatere** based on expert advice that Kā Roimata-o-Hinehukatere is the correct orthography of the Māori part of the dual name.

and

Accepted a different proposal from the Board to **alter** the official dual name Franz Josef Glacier/Kā Roimata o Hine Hukatere to **Franz Joseph Glacier / Kā Roimata-o-Hinehukatere**,

and

Accepted the proposal to **alter** the official dual name of the village Franz Josef/Waiau to **Franz Joseph** / **Waiau** based on:

- the updated legal opinion of 7 July 2023 that place names in the Ngāi Tahu Claims Settlement
 Act 1998 can be proposed to be altered through the process set out in sections 16-21 of the
 New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008,
- the Board's statutory obligation under sections 11(1)(b) and 10(1)(c) of the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008 to examine and correct the spelling of the names, and
- TRONT confirming they have no issues with correcting the non-Māori parts of the dual names, ie Joseph.

And

Will **notify** as proposals to alter for one month.

Subject to TRONT confirming the updated orthography, Kā Roimata-o-Hinehukatere, **noting** that Kā Huru Manu has the spelling Kā Roimata-a-Hinehukatere.

Noting the potential for objections to either or both parts of the dual names and advice from Te Arawhiti that in the interests of a good working Treaty partnership the Board seek the written consent of the Ngāi Tahu Trust Board regardless.

Charlotte Jones from Toitū Te Whenua LINZ Comms introduced herself. She is covering for Elizabeth Garlick and will be supporting the Board with media communications.

10.35 am – Robert Pouwhare joined the hui by Teams.

9.2. Parahaki

The Board noted the information and report provided (Objective ID A5587138). Parahaki (island) will be affected by the new Te Ahu-a-Tūranga highway with a new bridge to go over the eastern end of the island. The elevation data shows that at 8m the island is relatively flat. The Board noted that Motuere and Parahaki have been used for the island and the spit and that Parahaki may have been translocated from the spit to the island because of changes to the topography.

The meaning supplied for the name relies on a loan word but Parahaki could have other meanings with 'Para' and 'Haki' being a traditional reference to the clearing of the clouds. The Board considered it was up to mana whenua to tell the Board what the name meant to them and agreed that the name was clearly relevant to the area.

Resolution

The Board **accepted** the proposal to **approve** the unofficial recorded place name **Parahaki** as the official name of the island at the confluence of Manawatū River and Pohangina River, just southeast of Ashhurst, based on:

- the Board's function to encourage the use of original Māori place names,
- historical evidence for use of Parahaki for the island, including on some official maps,
- evidence of continued contemporary use of Parahaki (or Parahaki Island),
- officially naming the island being useful for identification, including to emergency services, but considering the addition of a generic term to be unnecessary,
- there being no other alternative recorded names known for the island, noting other names used historically such as Motuere and Rabbit Island are not 'alternative recorded names' under the definition in the Act,
- confirmation of the orthography, and
- public objection being unlikely,

Noting the possibility that the name Parahaki may have been translocated from another riverside feature no longer existing due to river deviation,

and

Will **notify** as a proposal to approve for **one** month.

Further discussion

The Board viewed a set of overlaid survey plans and aerial photography showing the changes to the island over ~160 years and noted that the proposers have plans to revegetate Parahaki and build a papakāinga.

[Secretariat note: On 4 October 2023 the Chairperson requested the Board to reconsider the legal process to make Parahaki official. The Board had agreed at its 3 October 2023 hui to publicly notify the name for one month. The Board subsequently agreed by email that its decision to support the proposal stood but it hadn't fully discussed the different avenues for the name to be made official. The Board

therefore subsequently agreed to notify the name as official under section 24 of the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008 without public consultation as the requirements for this process had been met. Objective ID A5881858 refers.

Updated Resolution

The Board **accepted** the proposal to **approve** the unofficial recorded place name **Parahaki** as the official name of the island at the confluence of Manawatū River and Pohangina River, just southeast of Ashhurst, based on:

- the Board's function to encourage the use of original Māori place names,
- historical evidence for use of Parahaki for the island, including on some official maps,
- evidence of continued contemporary use of Parahaki (or Parahaki Island),
- officially naming the island being useful for identification, including to emergency services, but considering the addition of a generic term to be unnecessary,
- there being no other alternative recorded names known for the island, noting other names used historically such as Motuere and Rabbit Island are not 'alternative recorded names' under the definition in the Act,
- confirmation of the orthography, and
- public objection being unlikely,

Noting the possibility that the name Parahaki may have been translocated from another riverside feature no longer existing due to river deviation,

and

Will **notify** as an **approved** official place name in terms of s.24 and s.21(2) of the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008 (ie, without public consultation).

9.3. Manawatū District

The Board noted the information and report provided (Objective ID A5575636). For consistency with the orthography of the region's name, Manawatu District Council had resolved to alter the name of its district from Manawatu District to Manawatu District. The council has consulted widely and provided extensive written support for the change.

The proposal is to standardise the name with a macron, not alter it. The Board questioned whether there are any alternatives to the lengthy process for altering a district's name, noting that a local authority can't change its operating name until the district name is changed. The Board considered whether sections 23-24 of the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008 could provide a way forward. However, section 22 sets out the process the Board must follow for altering a local authority's name. The Board agreed to accept the Secretariat's recommendation but subject to the Secretariat obtaining legal advice on whether any alternative means could be used instead to accelerate the proposal.

The Board agreed that for consistency it should update Manawatu Gorge to Manawatu Gorge in the Gazetteer and request Toitū Te Whenua LINZ's Topo team to update Manawatu Gorge to Manawatu Gorge on official topographic maps.

Resolution

Subject to the Secretary obtaining legal advice regarding any faster alternative processes to standardise the district name, the Board **accepted** the proposal to **alter** the official name Manawatu District to **Manawatū District** for the district (as defined in Section 5 and listed in Schedule 2 Part 2 of the Local Government Act 2002), based on:

- the resolution of Manawatu District Council to alter its district name,
- the Board meeting its statutory duty and function to 'enable certain administrative needs of government to be met',
- Manawatū being the correct standardised orthography as previously advised by an expert licensed translator,
- consistency with Manawatū-Whanganui Region and the district's namesake Manawatū River,
- evidence of support from several marae and several iwi and hapū groups, and
- evidence of support from six territorial authorities and the relevant regional council,

Noting processes are underway to standardise the names of three associated Crown protected areas, and

Will **notify** as a proposal to **alter** for one month,

and

Request Toitū Te Whenua LINZ's Topo team to **update** Manawatu Gorge to **Manawatū Gorge** on official topographic maps, based on the desire to provide consistent orthography for all Manawatū place names. The unofficial recorded¹ name will then be updated in the Gazetteer,

Noting Manawatu Gorge was not recommended for approval as an official name (as Manawatū Gorge) in 2020 due to its original Māori name being Te Āpiti.

[Secretariat note: On 16 October 2023 the Secretary requested legal advice on whether an alternative process could be followed that doesn't require public notification, ie could the section 24 fast track process be used for adding macrons to the district or region names of local authorities. On 25 October 2023 the Toitū Te Whenua LINZ Legal team responded 'no' and that the only other course of action would be a legislative amendment. Objective ID A5930080 refers. Therefore, the Secretariat publicly notified this proposal for one month.]

9.4. Waimarino, Waimarino Railway Station

The Board noted the information and report provided (Objective ID A5598790). The earlier change from Waimarino to National Park reflected it being a destination reached by rail. The Board noted that should it accept the proposals, it would be a clear indication of what it considers to be the best outcomes, but the proposals need to be carefully considered at this stage. The Board noted there has been a good range of support for the proposals and some interest in the media.

¹ A recorded place name is one that has appeared on at least two authoritative maps, charts or databases, which the Board has resolved to be: NZMS map, LINZ Archived Place Names Database, <u>Kā Huru Manu</u>, and all hydrographic and bathymetric maps and charts published under a New Zealand hydrographic authority at the time of publication. It is not official.

The Board questioned the consultation with mana whenua to date and suggested that Ngāti Tūwharetoa should also be consulted noting their role on the Taupō Tongariro Conservation Board. The Secretary advised that consultation so far has been based on Te Puni Kōkiri's *Te Kāhui Māngai* which provides an indication of areas of interest. In terms of the Board's *Kaupapa for Māori Place Names* iwi are advised of upcoming consultations five weeks before public notification to give the groups more time to respond.

Noting that one of the proposals is for just Waimarino (locality) with no generic term, the Board considered whether a generic term, for example, 'Village' should form part of the name. With regard to the wider administrative locality in the *NZ Suburbs and Localities* dataset, which is currently named National Park, it would also need to be changed to Waimarino, so the Secretariat would advise Toitū Te Whenua LINZ to update the dataset should the proposal be successful. It would also be recommended that the locality to the south currently called Waimarino be changed to another name, and there may be implications for other locality names in that dataset too.

The Board agreed to notify the proposals for three months, expecting considerable public interest.

Resolutions

The Board **accepted** the proposal to **alter** the existing unofficial recorded village name National Park to the official village name **Waimarino**, based on:

- the Board's function to encourage the use of original M\u00e4ori names, and recognising the traditional narratives and cultural values associated with the name Waimarino and the area as it originally applied to,
- the existing name National Park not being suitable for a village and creating confusion, as there are many actual national parks,
- evidence of support from:
 - Ōwhango-National Park Community Board,
 - Ruapehu District Council (the relevant Local authority),
 - Federated Mountain Clubs of New Zealand,
 - Tongariro-Taupō Conservation Board,
 - KiwiRail,
 - Visit Ruapehu.
- some evidence of local support (ie those living in the area), noting there is also evidence of local opposition, and
- the Board's primary responsibility to name geographic features and its purpose to achieve a
 coordinated and standardised approach to official naming, noting evidence of longstanding
 confusion about the name of the village is partly as no name was made official through a
 statutory process,

Noting that the wider 'National Park' addressable locality in the NZ Suburbs and Localities dataset managed by Toitū Te Whenua LINZ, which the proposed Waimarino (village) and Waimarino Station sit within, would need to be changed to Waimarino; and an existing nearby addressable locality 'Waimarino' to the south would need to be changed as well; so as to avoid confusion,

Noting the implications for associated Community Board names which are not in the Board's naming jurisdiction,

and

will **notify** as a proposal to alter for three months.

AND

The Board declined the proposal to alter National Park Station to Waimarino Station,

and

Accepted a new proposal from the Board to **alter** the existing unofficial recorded railway station name National Park Station to the official name **Waimarino Railway Station**, based on:

- the Board's longstanding consideration that railway stations should typically be named for the populated places they service, for consistency and to prevent confusion for travellers and tourists.
- ensuring standard and consistent generic terminology for official railway station names, ie 'Railway Station' not 'Station',
- KiwiRail's agreement to the proposal, being the rail operator, which is a Board requirement for railway feature name proposals, and
- support from Ōwhango-National Park Community Board and Ruapehu District Council, and likely support from the other institutions which specifically supported the proposed name of the village,

and

Will **notify** as a proposal to alter for three months.

10. Crown protected area names | Ngā taunahatanga e tiakina ana e te Karauna

10.1. Ototara or Ōtōtara Scientific Reserve

The Board noted the information and report provided (Objective ID A5576633). The Chairperson introduced Sheryll Johnson.

Under the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008 the Board must review proposals from DOC to name Crown protected areas and decide whether or not it concurs. The Board has delegated this review and concurrence function to the Secretary who checks that the proposed name meets the criteria in the *Standard for Crown protected area names*. This allows DOC's proposals to be actioned in a timely manner instead of waiting for one of the three Board hui each year. However, if the Secretary doesn't concur the proposal is escalated to the Board, which is what has happened in this case. If the Board still doesn't concur, then it reports its non-concurrence to the Minister of Conservation who makes the final decision.

In this case the issue is that the Board has had expert advice that the correct orthography is Ōtōtara, with macrons on the possessive [Ō] and tōtara for the tree, which is the only meaning, but the iwi didn't want the macrons. The lack of information in the proposal supporting or explaining the position of the iwi makes a decision difficult. The Board discussed whether the macrons change the meaning of the word. DOC had commented that the iwi considered it would be offensive as in its Treaty settlement the name has been written without macrons. However, Ototara hadn't been proposed as a Treaty place name so the Board hadn't considered it and therefore no check had been done on the orthography. There were no macrons at all in the Rangitāne o Manawatū Deed of Settlement, even on Manawatū, which is part of the name of the iwi. Therefore, Te Arawhiti may not have checked the orthography of the name either. The Board discussed whether the opposition to macrons was a

generational issue, and whether if it concurred with what the iwi are seeking now, the name might come back again one day to be standardised.

Te reo Māori was not originally a written language and macrons hadn't been endorsed as part of the language's orthography until recently. The Board considered that part of maintaining its own mana is to keep a consistent position on standard orthography rather than acceding to local interests.

Resolution (1st, withdrawn)

The Board **does not concur** with this proposal to assign a new official CPA name **Ototara Scientific Reserve**, based on the correct orthography with macrons not being applied and therefore the proposal not meeting clause 3.5(b) of the Standard for Crown protected area names NZGBS60001 (dated 11 May 2020).

Noting that the Rangitāne o Manawatū Deed of Settlement did not include the correct orthography for the one reference to a site of significance named Ototara in the Document Schedule,

and

Will **report** the Board's recommendation to the Minister of Conservation under s.29(1) of the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008, for a final determination.

Further discussion

Robert Tauwhare emphasised that the position of Te Taura Whiri i te Reo Māori is to ensure consistency with the use of macrons and noted other examples of 'tōtara' names.

The Board again noted the inconsistent use of macrons in the Rangitāne o Manawatū Treaty settlement documents and wondered if Option 3 might be more appropriate, which would allow for further discussion with Rangitāne o Manawatū about its orthographic preferences and see if they would accept Ōtōtara Scientific Reserve.

The observer from DOC advised that DOC had asked the iwi about the name twice but DOC hasn't gone back to the iwi again following the Secretary's review and non-concurrence. The DOC team were concerned that going back a third time would appear disrespectful and the views of the iwi on the name were being ignored. DOC could communicate the Board's views to the iwi if that was what the Board wants.

The Board noted that in terms of Ngāi Tahu's *Kā Huru Manu* work, it sometimes adopts a position of omitting macrons entirely if there is doubt about the meaning of the name, as the macrons might suggest one meaning or another is correct. However, for tōtara as a word there doesn't appear to be any other options. This isn't a matter of respect or disrespect, just of consistency.

A further possibility is that [Tō tara] is an offensive term aimed at women, so it was possible that the iwi didn't wish to explain this. However, even if this was the case, the orthography would still be the same with macrons on the [o]s.

The Board agreed to defer the proposal for DOC to discuss the use of macrons further with Rangitāne o Manawatū. However, it expressed concern about causing further offence to Rangitāne o Manawatū and the decision-making taking longer.

Resolution (2nd, accepted)

The Board agreed to **defer** this proposal to assign a new official CPA name **Ototara Scientific Reserve**, for further discussion by the Secretary and DOC with Rangitāne o Manawatū about its orthography preference setting out the Board's rationale for its decision to have macrons, to see if they would accept **Ōtōtara Scientific Reserve**, meaning that the Board could concur, and no report would need to go to the Minister of Conservation.

However, if Rangitāne o Manawatū hold to no macrons, then the Board will **report** the Board's recommendation for **Ōtōtara Scientific Reserve** to the Minister of Conservation under s.29(1) of the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008, for a final determination.

The Board discussed procedure now that it had two motions on the table. Dr Cadence Kaumoana agreed to withdraw her motion of Option 1 (from Objective ID A5576633). The Chairperson asked for those who were in favour of Option 3 (Objective ID A5576633).

Further discussion

The observer from DOC asked if DOC had provided enough information to the Board. The Board confirmed that DOC had and considered the fundamental issue was that the story for the name was missing, which lead to this discussion.

Actions required

- Secretary to request DOC to discuss the use of the macrons further with Rangitāne o Manawatū and ask why Rangitāne does not support the macrons in the name.
- If Rangitāne o Manawatū continue to uphold no macrons, then the Board is unable to concur with the proposal, and the Secretary to proceed with a report on the Board's decision for Ōtōtara Scientific Reserve to the Minister of Conservation, seeking a final determination.

[Secretariat note: On 6 October 2023 the Secretary requested DOC to consult further with Rangitāne o Manawatū about the macrons and their story. On 6 November 2023 DOC responded that they maintain no macrons. They did not provide more information. Objective ID A5952939 refers. Therefore, the Secretariat proceeded to report the Board's non-concurrence to the Minister of Conservation for the final determination.]

13. Approval of recorded names as official | Whakaaetanga kia mana ngā ingo akua takoto

Additional information tabled

 Response from Ngāti Tamaoho requesting that four unofficial recorded place names in Appendix A be withdrawn from being approved as official (Objective ID A5876127).

The Board noted the information and report provided (Objective ID A5534675) and the late information from Ngāti Tamaoho. The Board thanked the Secretariat for the work done on this and the clarity of the information. The Board also thanked Merata Kawharu who had liaised with Ngāti Whātua Ōrākei and provided advice to the Secretariat.

The Board agreed to the request from Ngāti Tamaoho to withdraw Pāhurehure (suburb), Pāhurehure Inlet, Pararēkau Island and Puhinui Creek from Appendix A and move them to Appendix D noting that they will remain as unofficial recorded place names. This will make the new totals 525 names in Appendix A and 83 names in Appendix D. The Board agreed to approve the remaining 525 unofficial recorded Māori place names in Appendix A and the 16 unofficial recorded Māori place names in Appendix B as official. The Board also agreed to the recommendations in Appendices C-E.

Resolutions

The Board **approved** as **official** the **525** unofficial recorded Māori place names in **Appendix A** based on:

- there being no alternative recorded place names known for the features,
- public objection being unlikely, and
- the Board previously agreeing that the addition of a macron does not prevent a recorded Māori place name being approved as official because it is not an alternative name (applies to 186 of the names).

Noting that:

- the 207 names marked with an asterisk are supported by the Auckland Council Local Boards whose jurisdiction the features fall within,
- the only feedback from mana whenua on these names has been from Ngāti Whātua Ōrākei for this project and Ngāti Manuhiri via the Tangata Whenua Place Names maps project,
- the Board's fast track programme provides that if no response is received by a reasonable deadline it may proceed to make the recorded place names official, and
- if there are any issues, they can be resolved in the future.

and

Will **notify** the 525 Māori place names approved as official in terms of section 21(2) of the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008.

and

Approved as **official** the **16** unofficial recorded Māori place names in **Appendix B** based on:

- there being no alternative recorded place names known for the features,
- public objection being unlikely, and
- the Board previously agreeing that the addition of a macron does not prevent a recorded Māori place name being approved as official because it is not an alternative name (applies to 8 of the names).

Noting that

- Ngāti Whātua has confirmed Ōkahu Bay and Ōrākei,
- there are associated features with a long-form names,
- the long-form names aren't shown on authoritative documents for these 16 features, so they are not considered to be 'alternative recorded names' under section 24 of the NZGB Act 2008, and
- if there are any issues, they can be resolved in the future.

and

Will **notify** the 16 Māori place names approved as official in terms of section 21(2) of the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008.

and

The Board **declined to approve** the **119** unofficial recorded Māori place names in **Appendix C** based on the Board's expert translator requiring more information before being able to advise the correct orthography.

Noting that these 119 place names will continue to be classified as unofficial recorded place names and used on maps, charts and other official documents.

and

The Board **declined to approve** the **83** unofficial recorded Māori place names in **Appendix D** based on them having issues such as:

- either mana whenua or an Auckland Council Local Board not supporting that they be approved as official,
- being features outside of the Board's naming jurisdiction (a Girls Guides' lodge),
- Reed recording an original Māori name or for the feature or possible spelling correction,
- the generic term 'Railway' not being included in railway station names, and
- the name being part of an existing recorded dual place name.

Noting that these 83 place names will continue to be classified as unofficial recorded place names and used on maps, charts and other official documents.

and

Will **notify amendments** to **13** existing official Crown protected area names in **Appendix E** by adding macrons for consistency with the recorded place names in Appendix A, **subject** to confirmation by the Department of Conservation.

Committees | Ngā Komiti

14. Undersea Feature Names Committee | Komiti Ingoa mō Tārainga Takere Moana

The Board noted the information and report provided (Objective ID A5557892). The Board noted the progress with the 15 proposals from the Alfred Wegener Institute for Polar and Marine Research.

The Board noted that an article by the BBC², which has been shared by Radio NZ, has again raised the issue of naming of the continent that New Zealand sits upon. Zealandia and the dual name Te Riu-a-Māui / Zealandia are becoming commonly used. Therefore, it is important that the Board reconsiders officially naming the feature. Despite the feature overlapping with Australia and New Caledonia, the Board could consider a proposal to name the part of the feature that is within New Zealand's naming jurisdiction, or alternatively give advice on a name.

While the Board has previously discussed naming the feature, GNS Science hasn't yet submitted a formal proposal. In 2019 the Māori Names Committee provided feedback on 'Te Riu-a-Māui' and suggested that 'Tangaroa' would be more appropriate than 'Māui'. Noting that Tangaroa is a male name, the Board wondered if a female name or Te Riu-a-Mako might be appropriate. The Board discussed providing options for names to GNS Science, however it agreed to leave the future proposal to GNS Science, noting that it would be most appropriate for them to consult.

The Board noted and was impressed by a new paper dated 6 September 2023 that GNS Science has provided on naming the continental block, advising that it had taken the initiative of seeking an acceptable Māori-Polynesian name and put forward the dual name Te Riu-a-Māui / Zealandia.

A difficulty in the Board considering a future proposal from GNS Science is that the Board's jurisdiction extends to the Extended Continental Shelf, which is a political boundary. The physical extent of the whole continent is beyond that boundary, however, the proposed Te Riu-a-Māui / Zealandia is not. The Board considered the feasibility of naming the entire feature, even if it might only be recognised in New Zealand. However, that may have adverse geo-political implications internationally.

The Board has several options for considering this proposal, such as to name only the part of the feature that is within its jurisdiction or advise GNS Science to agree on a name with Australia and New

Caledonia [France] who partially overlap the feature and therefore have a sovereign interest or decline the proposal. The Board wondered if other Pasifika nations should be consulted, but noted this would just be out of courtesy as the continent doesn't extend to them.

The Board agreed that it supports naming the continent in principle and that it has the authority to make a name official within New Zealand's Extended Continental Shelf boundary, but it will be up to GNS Science to make the proposal and consult internationally. The Board agreed that it would encourage GNS Science to make a formal proposal and that the Secretariat would provide international contacts.

Resolution

That the Board encourages GNS Science to make a formal proposal to name the continent, including consultation with Australia and New Caledonia [France].

15. Komiti Taunahatanga Māori

Additional information tabled:

Summary of Komiti hui 2 October 2023 (Objective ID A5877326).

The Board noted the information and report provided (Objective ID A5604583). Mahana Toka provided a verbal update on the Komiti hui held on 2 October 2023. Co-Chair Matanuku Mahuika is considering stepping down from the Komiti, but at their request has agreed to stay on for another 12 months to provide continuity for the newer Komiti members. His membership will be reviewed again in a year's time. The Komiti noted that the continued membership of former Board member Shane Te Ruki is still to be confirmed.

The Komiti would like to meet with Te Mātāwai and Te Taura Whiri i te Reo Māori for whakawhanaungatanga (to establish relationships), but this is still to be arranged and confirmed. The Komiti had discussed the upcoming centenary programme and potential ideas such as podcasts and oral history interviews with people such as Tā Tipene O'Regan about the restoration of Māori place names. They also discussed having the Komiti minutes translated into te reo Māori and queried the budget for this and its priority in terms of the Board's other mahi. The Secretariat will cost having the minutes translated and report back to the Komiti. However, the funding allocation will be determined by Toitū Te Whenua LINZ.

The Komiti membership was recommended to the Board, noting that the appointment of members to Board committees is a formal process under the New Zealand Geographic Board (Ngā Pou Taunaha o Aotearoa) Act 2008.

The Board queried the membership of its other two committees following the departure of Bonita Bingham, Chanel Clarke and Shane Te Ruki from the Board. The current Board membership on the Antarctic Names Committee and Undersea Feature Names Committee was noted as currently:

- Paulette Tamati-Elliffe remains as Co-Chair,
- Tāne Karamaina is the new Te Taura Whiri i te Reo Māori representative on the Komiti (with Robert Pouwhare available to deputise if needed), and
- Waihoroi Shortland remains as the Te Puni Kōkiri representative.

16. Policies | Ngā Kaupapa here

The Board noted the information and report provided (Objective ID A5578493). The Secretary provided a brief summary to the Board, noting that Toitū Te Whenua LINZ is currently looking at agency guidance on remuneration for Māori. The Board would follow whatever guidance is developed, noting the question of remuneration for Māori has been put to the Board many times, but declined.

The Board noted that its standards are being updated with the additions it has previously agreed to (gender balance, inclusion and diversity) and queried if it has a role in the review process. The

Secretary clarified that policies are largely considered to be operational matters although the Board does have a formal role in endorsing standards.

Outreach | Toronga

17. Outreach and Engagement | Toronga me to Whakawhanaunga

17.1. Centenary

The Board noted the information and report provided (Objective ID A5589691). The Board noted this correction to the report: page 1: the Honorary Geographic Board first met in September 1924, not September 1923.

The Board's ability to deliver on the proposed centenary initiatives and priorities will depend on the final budget for this work. The Board's budget has already been reduced slightly and may need to be reduced by at least a further 6.5% should there be a change of government. The Board will need to be very mindful of spending for the centenary and accountability. The focus is likely to be on the initiatives that are relatively low cost such as the series of 12 monthly articles. An option for the 12 articles could be to have one or two essays which speak to the topic of 'what's in a name?', written from a hapū or marae perspective. The intention being to cover history, understanding and connection.

The Board agreed that it's important to have an event to focus the centenary on, such as the proposed Parliamentary breakfast. This would likely generate media interest but would require a conversation with the Minister for Land Information who would need to host it. The breakfast would probably occur in the 2024/2025 financial year to align with the September date when the first Honorary Geographic Board meeting was held. The Board supported branding initiatives for the centenary, including email signatures.

Actions required

- Secretary to amend its report to the Board (Objective ID A5589691) from September 1923 to September 1924.
- Secretary to pursue one or two essays which speak to the topic of 'what's in a name?', written from a hapū or marae perspective.
- Secretary to pursue the Parliamentary breakfast event in September 2024.

18. Projects, initiatives | Ngā mahi, ngā kaupapa

18.1. Kā Huru Manu update and Marlborough Region names

The Board noted the information and report provided (Objective ID A5558024). The project to align the Gazetteer with *Kā Huru Manu*, which began in 2019, is back after a hiatus of a few years. It is slowly recommencing with the few remaining Marlborough Region names. The project follows a process agreed with Ngāi Tahu after the Board recognised *Kā Huru Manu* as an authoritative source for place names in 2018.

The outcomes for the *Kā Huru Manu* names under this process include:

- collecting names
- recording new names then fast-tracking them to be approved as official
- fast-tracking existing recorded names to be approved as official
- updating and correcting existing official names
- adding *Kā Huru Manu* links to existing *NZ Gazetteer* entries (where the names are exactly as per *Kā Huru Manu*).

The Board noted that many decisions previously identified under this process have instead been recently completed with the publication of the new Tangata Whenua Place Names map for Te Waipounamu (for example, the collection of unofficial place names). However, there is still project work to be done across the regions, and Ngāi Tahu intend to eventually publish another ~1500 names in Kā Huru Manu.

Resolution

The Board will **notify** an amending notice in the New Zealand Gazette to standardise Waima River with a macron, as **Waimā River**,

and

Noting that **Kaparatehau**, **Te Parinui-o-Whiti**, and **Te Rae-o-te-Kōhaka** have been collected and published in the NZ Gazetteer against the two existing official Ngāi Tahu Treaty names and one existing recorded name (refer Appendix A in the report (Objective ID A5558024)),

Noting that two collected names (Kaparatehau, Te Parinui-o-Whiti) against the official dual Treaty names will be removed if/when the spelling/orthography are corrected (refer Agenda item 9.1).

18.2. Tangata Whenua Place Names maps launch and distribution

The Board noted the information and report provided (Objective ID A5607580). The Board agreed that the report is a useful record of the project and noted there is no update on the Toitū Te Whenua LINZ proposal to install oversized versions of the maps in the foyer of 155 The Terrace, Wellington. The Board could potentially assist with the whakataukī proposed to be inserted between the two maps.

Action required

• Secretariat to advise Toitū Te Whenua LINZ of the Board's offer to assist with the whakataukī proposed between the two foyer maps.

18.3. Other projects and initiatives

The Board noted the information and report provided (Objective ID A5583973). The Secretary encouraged the Board to look at some of Mike Roche's history/origin/meaning stories that have been added to names in the Gazetteer. The Board noted that 4,230 Māori names in the Gazetteer now have audio files to assist with pronunciation, and that audio files will be completed for another ~1000 names in November 2023. The next batch will also cover names newly collected from the *Tangata Whenua Place Names* maps. The Board noted that it was fairly costly to record the audio files but positive feedback has been received, demonstrating the benefit of the project.

19. Secretariat's update | Kōrero hou a te Hekeretari

The Board noted the information and report provided (Objective ID A5551895). The Board's Annual Report will be printed and sent to the Minister's Office on 11 October 2023, for tabling in Parliament on 20 October 2023. All Board members and observers will receive a hard copy. The Board acknowledged the work involved in completing the Annual Report, which is largely undertaken by the Secretary.

The Board also noted:

- An update on the judicial review for Ōmiha.
- Non-compliance examples in Air New Zealand's *Kia Ora* magazine which is an official publication used for travellers as defined in the NZGB Act 2008.
- The Secretariat is working closely with the Toitū Te Whenua LINZ's Addressing team to manage changes to addressable localities in the LINZ NZ Suburbs and Localities dataset. There will be a panel to consider any changes and the Board will have a role on this panel. The Board will need to be involved if there are major changes to existing suburbs and localities in the dataset, or if new suburbs and localities are created. For boundary amendments, the change request process via the NZ Suburbs and Localities dataset might be a better option than the Board's process, noting the difficulties with defining boundaries via the Board's process, as happened recently with Rangiriri and Whangamarino.
- The enquiry re public engagement and democracy and confirmed that no further response is required.
- The Secretary's considerable contribution as a rapporteur at the 3rd UNGEGN³ session.
- New Zealand's significant contribution to the ANZ WGPN⁴ and the Secretary's virtual attendance at the upcoming annual meeting in Hobart.
- Actions from the latest SCAGI⁵ meeting, which can be provided to any interested Board members.
- All the Secretariat work that goes on in the background such as responding to Official Information Act requests and parliamentary questions can be very time-consuming. There is an ongoing OIA request regarding the costs of producing the new *Tangata Whenua Place Names* maps.

The Secretariat thanked the Secretary Wendy Shaw for her leadership and management of the team.

The Board noted the information and report provided (Objective ID A5607011). The Board discussed proposed timings for its three 2024 hui, which are tentatively scheduled for March/April, June/July and October/November. The Undersea Feature Names Committee and Antarctic Places Names Committee hui are planned to possibly be in February 2024.
