

CROWN PASTORAL LAND ACT 1998

LOWBURN VALLEY TENURE REVIEW

NOTICE OF PRELIMINARY PROPOSAL

Notice is given under Section 43 of the Crown Pastoral Land Act 1998 by the Commissioner of Crown Lands that he has put a preliminary proposal for tenure review to Lowburn Station Limited as lessee of Lowburn Valley pastoral lease.

Legal description of land concerned:

Pastoral lease land:

Run 634 Cromwell Survey District being all the land in Record of Title OTA2/1222 (Otago Land Registry) comprising 5,814.1920 hectares more or less.

General description of proposal:

- 1. An area of approximately 1,919 hectares to be restored to or retained in Crown control as Conservation Area pursuant to Section 35(2)(b)(i) Crown Pastoral Land Act 1998 subject to:
 - 1.1 An easement for farm management purposes.
- 2. An area of approximately 3,895 hectares to be disposed of by freehold disposal to the lessee of Lowburn Valley pastoral lease, pursuant to Section 35(3) Crown Pastoral Land Act 1998; subject to:
 - 2.1 Part IVA of the Conservation Act 1987;
 - 2.2 Section 11 of the Crown Minerals Act 1991.
 - 2.3 Easements for public and conservation management access.
 - 2.4 Conservation covenants over an area of approximately 1,341 hectares.
 - 2.5 Continuation in force of the easement registered as 756347
 - 2.6 Continuation in force of the easement registered as 8493630.1
