Response to your official information request

- the amount of FTEs and the proposed ideal amount of FTEs under the new Government's cost saving model in the public service, and
- a copy of communication between the Ministry and the Minister, on the topic of cost savings, job cuts, and potentia restructuring.

One briefing in scope, BRF 24-259 – Briefing to the Minister for Land Information on the Savings Response to the Minister of Finance dated 23 January 2024, has been withheld under sections:

- 9(2)(f)(iv) of the Official Information Act to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials
- 9(2)(g)(i) of the Official Information Act to maintain the effective conduct of public affairs through the free and frank expression of opinions.

We are of the view the withholding of the information is not outweighed by the public interest to make that information available.

Your request for "the amount of FTEs and the proposed ideal amount of FTEs under the new Government's cost saving model in the public service," is declined as no such numbers have been discussed. This part of the request is being refused under section 18(e) of the Official Information Act as the information does not exist.
