Site inspections have been undertaken by both organisations and recommendations have been received from both WAC and DOC although DOC is yet to complete its site visit and investigations. Their recommendations will be incorporated into the overall conservation and ecological management plan being developed for the property. It is proposed there will be ongoing consultation and dialogue with both organisations during December 2017 and in 2018.

- 4. In respect of Special Condition 13, in addition to the information noted above we confirm:

#### Condition 3 – Additional Investment

- 1. Restoration/Enhancement Blue Lake's has instructed Dr Mick Abbott of Lincoln University to oversee restoration works for Guide Hill Station. The following restoration and enhancement works have either been completed, or scheduled for completion by 31 December 2018:
  - a. Fencing off from stock three blocks totally approximately 24ha in Boltons Gully, to allow native biodiversity to re-establish.
  - b. Modifying one of the small irrigation lakes to allow Kaki (Black Stilt) to nest. This work has been undertaken in conjunction with the Department of Conversation ("DOC"). This work has been extremely successful with one breeding pair of this endangered bird currently established at the site.
  - c. Fencing off research plots in the Maryburn Drylands Area. Each plot is 30mx30m and excludes deer, sheep, cattle and rabbits so the effects of grazing can be monitored.
  - d. Removing invasive Wilding Conifers from the property. This work has been undertaken in conjunction with Environment Canterbury.
  - e. Removing invasive Willows from Bolton's Gully This work has been undertaken in conjunction with DOC.
  - f. Establishing a site for planting of native plants site using experimental direct-drilling techniques. This ongoing work is being undertaken in conjunction with DOC.
  - g. Raising, since 2017, eco-sourced totara and other native species at a DOC Nursery. These are to be planted in Autumn 2019, when establishment rates are strongest.
  - h. Purchasing materials and equipment to allow access to assess and protect wetland values in the Black Hole, to set up plant nursery, for ongoing volunteer planting, ongoing monitoring and removing pests.
  - i. Establishing photo point survey sites and programme including use of detailed drone footage.
  - j. Working with NEXT foundation and DOC to support the Te Manahuna Aoraki Predator Free Project that includes Guide Hill Station.

k. Development of a farm-wide management plan to support biodiversity outcomes.

The value of these restoration and enhancement works being undertaken prior to 31 December 2018 exceeds \$200,000.00.

Research Facility – the research facility has received both resource and building consent. The
facility is under construction. The construction contract provides for completion by 31 December
2018.

The purchase of a mobile research facility to supplement the permanent facility at Guide Hill Station will be completed this year. The cost of the vehicle is \$73,000.00 and the mobile facility cost is \$40,000.00.

- 3. New Farm Irrigation as per our report on 1 March 2017 the irrigation has been installed and is operational.
- 4. New Lodge as previously advised the application for resource consent for the lodge has been filed and is being processed as a Direct Referral application to the Environment Court. The application is adjourned pending the determination of the High Court declaration proceedings in respect of Land Information New Zealand's decision reneging on its original decision declaring the land as surplus and to offer back the land to the previous land owner so they can in turn on sell it to Blue Lake. The hearing of these proceedings is due to occur in the first half of 2019.
- Further Accommodation and tourist facilities as previously advised, Blue Lake filed with the Mackenzie District Council its application for resource consent for the farm-based accommodation and tourist activities on 19 January 2018. The resource consent for the tourism activity and the first stage of visitor accommodation was granted in July 2018. Construction is expected to commence in 2019.
