and our tranche one response of 16 August 2022.

We are now able to release the second tranche of documents being the assessment reports for Cases:

- Case 201620106 Mercury Medical Holdings Limited
- Case 201810128 InterOperability Bidco, Inc. and Healthier Populations Holdco Limited
- Case 202100727 I-MED New Zealand Bidco Limited

which are released in part with some information withheld under sections 9(2)(a) - to protect personal privacy and/or 9(2)(b)(ii) - where the release would be likely unreasonably to prejudice the commercial position of the person who supplied or who is the subject of the information.

We are of the view that the withholding of the information is not outweighed by other considerations which render it desirable in the public interest to make that information available.

In relation to the assessment report for Case 201810128 the applicant has requested that we advise you of a factual inaccuracy in paragraphs 18-22 of Appendix 3 of the report. They advise:

This text is incorrect. The applicant never had an equity interest in Concordia, but did own a legacy business which was sold to a party who merged it with an existing business that combined business being sold Concordia (i.e the applicant and its legacy business has at least two steps removed from Concordia) and that the following amended text ensures factual accuracy:

" 18. HgCapital LLP (HgCapital) was a previous owner of Mercury Pharma, a business acquired by Concordia, a pharmaceutical company that is presently being investigated by the UK Competition and Markets Authority regarding monopolistic behaviour which resulted in the price of a thyroid drug being increased by 6000%.

19. The Applicants informed us that Mercury Pharma was a business which HgCapital invested in from 2009 until 2012 when it stopped investing in the healthcare sector. The Applicants stated that HgCapital no longer has a healthcare investment team."

Also, in relation to paragraphs 24-26 of Appendix 3 of the report the applicant has advised:

That the "investigation" referred to is plainly irrelevant, given that the applicant did not proceed with the takeover (and there was no formal adverse finding from the regulators).

The text in the report has the potential to create some misunderstandings as to relevance of the issues reported.
