Response to your official information request

Thank you for your official information request received on 17 November 2024 requesting responses to several questions relating to the former Napier Prison and the involvement of Mana Ahuriri Trust.

The questions provided in your request and the corresponding responses are set out below.

Question 1: "What is Mana Ahuriri claiming on this hillside, and why should this property be handed to the Iwi? I would like spec fic historic details related to this corner of Coote Road and Marine Parade (1.6 hectares). What is the Iwi's history on the hillside? Other than the explanation provided here: https://issuu.com/herit.../docs/heritagenz_162/s/13168447..., I have not identified specific Māori activity on this particular property. I would like specific claim details of this area."

The property is managed by Toitū Te Whenua Land Information New Zealand (LINZ) in the Treaty Settlement Landbank to potentially be used as redre s in a Treaty Settlement.

This property entered the Landbank in June 2000 and was transferred to LINZ from the Ministry of Justice in July 2016. LINZ currently has no timeframe on when the Mana Ahuriri Trust may trigger the right to purchase process.

Question 2: "How much money has been spent on maintaining the Old Napier Prison in the last five ye rs? Please provide a breakdown of all running and maintenance costs to determine the ave age yearly expenditure on the prison's maintenance over the last 25 years."

Question 3: "I understand that LINZ is addressing repairs to the nner prison retaining wall. What other damages to the property or buildings will be fixed before the transfer to the Iwi? Please list these repairs that need to be completed. What are the projected costs and timelines for these repairs? Are you intending to remove these trees and repair the limestone wall on Marine Parade as well as the historic track up that hillside?"

LINZ currently plans to remediate four retaining walls (RW12, RW11, RW10 and RW17 on the map below) prior to potential transfer to iwi. Works are still in the early consent and planning phase and are estimated to cost up to \$2,000,000.

These are currently the only major works planned.

Question 4: "What is the Iwi's future management plan for this prison, and how do they intend to maintain it if they acquire the property?"

This information is not held by LINZ and we have no reason to believe that it is held by another agency. Therefore, we are refusing your request under 18(g) of the Official Information Act.

Question 5: "How does Mana Ahuriri plan to utilise this heritage proper y, and will it be open or accessible to the public? If not, why?"

This information is not held by LINZ and we have no reason to believe that it is held by another agency. Therefore, we are refusing your request under 18(g) of the Official Information Act.

Question 6: "Please supply a valuation or asking price for this property or what the offer to the Iwi would include when it is made."

LINZ does not have a valuation or current asking price for this property. The property is recorded as a Right of First Refusal (RFR) property in Āhuriri Hapū Deed of settlement. The RFR process requires LINZ to offer the property to Āhuriri Hapū based on a market valuation.
